

Mary Jo Carpenter Retires After 31 Years With Community Connection

## **A stylish send off for Mary Jo**

Mary Jo Carpenter capped off her 31-year career in style - Halloween style, dressed up as Mary Sanderson from the movie "Hocus Pocus."

It just happened that her

final day before retiring as manager of Community Connection was Oct. 31. She was joined in "Hocus Pocus" costume by

office staff Lori Barker (dressed as Winifred Sanderson) and Renee Green

who took on the character of

Sarah Sanderson. Joe Hayes took over as manager Nov. 1.

### How it started

Carpenter didn't really seek out this job.

"Literally, I needed a job," she said. "I didn't have a burning desire to be in social services. I didn't know it would turn into 30 years."

She served as assistant manager for eight years, then

moved into the manager position when Sherry Schaer, then manager, lost her battle with cancer.

Carpenter's career spanned many changes for Community Connection, She started as assistant manager

when it was still located at the Extension Office. She still recalls every August at that spot, when the bus barn was used for dairy cows and senior meals took a hiatus during the week of fair.

In 1999, Seniors Inc.

moved into a new building on Cedar Street, built on land the nonprofit had purchased from grants and \$75,000 in community dona-

# **Groups** object to plan

The U.S. Forest Service received 343 objections that met filing requirements, to the Blue Mountain Forest Plan Revision released in June.

Interested parties had a 60-day period after the release of the revision to submit objections to the plan. Among those with objections that met the requirements were all three Baker County commissioners, Baker County, the City of Sumpter, the Eastern Oregon Mining Association, Oregon Department of Fish and Wildlife, the Eastern Oregon Counties Association and more.

In total, the Forest Service received 350 objections, only seven of which did not meet the criteria to be further reviewed.

The next step in the process is for the Forest Service to schedule objection-resolution meetings. Those meetings are tentatively scheduled for Nov. 27 through Dec. 1.

## Baker toddler dies from gunshot wound

The Baker County Major Crime Team is continuing its investigation into the death of a 2-year-old boy who died Sunday at the Trauma Center in Boise of a gunshot wound, District Attorney Matt Shirtcliff stated in a press release.

Liam Mankins sustained the wound at about 11:15 a.m. at his home at 1905 Birch St.

His parents, Pete Mankins, 33, and Diana Goodman, 32, were at home at the time of the incident, Shirtcliff said.

The Oregon State Police crime lab is assisting in the investigation.

An ambulance, city police and county deputies were called to the Mankins' home Sunday morning. Liam was transported by ambulance to St. Alphonsus Medical Center and was immediately transferred to Boise by Life Flight.

The boy died of his injuries at 1:43 p.m. at the Boise Trauma Center, Shirtcliff

An autopsy is scheduled today in Boise, he added.
