# Bridgeport man faces multiple charges

A Bridgeport man was arrested on accusations of drunken driving and other crimes after he was found unconscious and unresponsive in his vehicle on Highway 7 just south of Baker City Wednesday night.

Rochefellor Harts Gillam, 28, regained consciousness after he was contacted by the Sheriff's Department as he sat in his vehicle that was stopped

and still running, a press release stated. "Once he regained consciousness, Gillam became uncooperative," according to the press release. "At the conclusion of the on-scene investigation, it was determined Gillam was under the influence of alcohol."

He was taken to the hospital where his blood was drawn as part of the investigation. While at the hospital he

damaged the ambulance bay access door and attempted to flee from deputies.

He was taken to the Baker County Jail where he was lodged and later released on charges of driving under the influence of intoxicants, first-degree criminal mischief, third-degree escape, interfering with a peace officer and illegal stopping.
