was absent Tuesday. He had informed the other councilors that he would miss Tuesday's meeting.

In other business Tuesday, councilors voted to award

a bid for repairing and recoating the exterior of a 3-million-gallon drinking water reservoir built in the early 1960s.

The reservoir has not required any significant maintenance or repair since then, city officials said.

The Council awarded

the \$84,280.47 contract to Cascade Industrial Services of Rathdrum, Idaho, the lowest of six bidders. Baker City's Public Works Advisory Committee recommended the Council award the bid to Cascade Industrial Services.

The company is required to finish the project before June

21, 2019.

Councilors also appointed Joseph Peterson to the Public Works Advisory Committee.

This leaves one vacant spot on the committee that will be filled by a councilor early next year when the three newly elected councilors are sworn in.

The thinning-and-piling work is part of the East Face project, which includes similar efforts on both public and private land on the east side of the Elkhorns and extending nearly to La Grande.

In addition to the piles beside the highway, workers also cut and piled trees in the Anthony Lakes Recreation Area, including campgrounds, said Noel Livingston, fire staff officer on the Wallowa-Whitman National Forest.

In many cases workers burn slash

without first piling it.

That wasn't feasible in this case, Livingston said, because there was enough debris on the ground to fuel a fire that would have killed the remaining trees.

That threat is especially acute in the higher elevations, including around Anthony Lakes, where the predominant trees are subalpine firs and lodgepole pines, a forest type where natural fires typically scorch all the trees, what foresters call a "stand-replacement" fire.

Burning the slash piles is a long-term project because the sheer number of piles means crews can only light about 25 percent of the piles in a given area on one day to prevent flames from spreading to the standing trees, Livingston said.

The East Face project isn't the only place on the Wallowa-Whitman where crews are burning slash piles this fall.

In all, officials hope to burn piles on about 1,900 acres across the forest, Livingston said.

"That's a lot of piles," he said.

Burning conditions have been generally good recently, he said. Snow earlier this month reduced the chances of fires spreading, and the cool, dry weather the past week has kept the piles dry enough that they'll burn readily.
