The pothole was a problem. But it wasn't the only potential pratfall for boaters using the only year-round access ramp at Phillips Reservoir.

The asphalt ramp near Mason Dam, built about half a century ago, was in pretty poor shape, said Dave Plummer, engineer for the Wallowa-Whitman National Forest, which is responsible for the ramp.

"The existing ramp had potholes, and one, right in the middle, was more than a foot deep," Plummer said. "We were getting a lot of complaints about it."

So was the Oregon State Marine Board. Officials from that agency encouraged the Wallowa-Whitman to apply for a grant to replace the ramp.

### Lawsuit **in 2013** murder settled

■ Carlotta Piete settles for \$1 million in the \$9.2 million suit she filed in 2015 after her husband, Michael, was killed by their foster son, Dillan Easley, in a cabin near Granite

A Baker City woman has been awarded \$1 million in an out-of-court settlement of her claim of negligence and wrongful death in a lawsuit filed in 2015 against the Department of Human Services and four other agencies, including Mountain Valley Mental Health Services in Baker City.

The complaint was filed in 2015 by Carlotta Piete, the personal representative of the estate of her late husband, Michael Piete, who was shot and killed by their foster son, Dillan Dakota Willford Easley, in October 2013.

Easley shot and killed Michael Piete, 43, and Piete's uncle, Kenneth Gilliland, 64, during a hunting trip in the Granite area. The Pietes had taken Easley into their home on Dry Creek Road near Baker City in 2012 when he was 13
