Their presentations are a summation of their FFA student careers that have led them to their ultimate achievement, the State FFA degree and gold pin award

To earn the Oregon FFA State degree, members must have met 10 requirements. They must have already earned the Chapter FFA degree and have been an active member for at least 2 years at the time of application. They must have taken two years of agriculture education, including a supervised agricultural experience (SAE) and invested \$1,500 for unpaid placement projects.

Also, they must have put in 500 hours in sales regardless of their project. They must also have demonstrated a high level of leadership abilities, earned a cumulative 2.0 grade point average or higher and participated in planning chapter activities.

Lastly, they must have participated in thirty FFA activities with 5 above the district level and participated in ten school or community activities, completing at least 25 hours of community service in more than two activities.

The two Enterprise FFA Chapter's senior members, who will receive their State FFA degrees, have completed the following projects and requirements.

Riley Masters has had projects that included lawn care, pet and home sitting businesses, as well as marketing swine. He has grown his clientele over the past two years, turning enough profit to purchase his own zero turn lawn mower this year. He hopes to continue to grow his businesses. He has participated in agriculture sales, parliamentary procedure, soil judging and livestock evaluation.

"Any deal would help alleviate some of the uncertainty," said Karyn Cavanaugh, senior markets strategist at Voya Investment Management. "The GDP hasn't been dinged that much from the trade tariffs, it's really been the uncertainty. It's spilling over into business plans and that's a hurdle for growth."

The S&P 500 index gained 34.93 points, or 1.3 percent, to 2,744.73. The Dow climbed 372.65 points, or 1.5 percent, to 25,425.76. The index was briefly up by 405 points.

The Nasdaq composite rose 106.71 points, or 1.5 percent, to 7,414.62. The Russell 2000 index of smaller-company stocks, which has been leading the other indexes this year, added 19.25 points, or 1.3 percent, to 1,538.23.

European markets fin-

ished higher.
Stocks got an early boost
Tuesday after lawmakers in
Washington reached a tentative deal to avoid another
partial government shutdown. The agreement on border security involves far less
money for a wall than the
White House wanted, and it's
not clear whether Trump will
support the deal

support the deal.
Still, the move alleviated some uncertainty for the market as the U.S. and China continue trade negotiations, which resumed Monday.

Fears of a global slowdown still linger. Europe and China have both reported slower growth. Those concerns have dimmed the outlook for corporate earnings growth this year.

The latest company earnings season has featured solid profit growth for the final three months of 2018, but caution about conditions going forward. Analysts predict profits will fall in the current quarter, according to FactSet

"Overall earnings are good, but we're looking for a bit of a slowdown in the first quarter because we have a high bar to hurdle over," Cavanaugh

Investors continued to size up the latest batch of corporate earnings Tuesday.

Under Armour climbed 6.9 percent after the maker of sportswear beat Wall Street forecasts. A surge in international sales offset a downturn in Under Armour's U.S. sales.

U.S. stock brokers had some uncertainty aleviated after lawmakers reached a tenative deal to avoid another partial government shutdown Tuesday.

Molson Coors plunged 9.4 percent as lower sales voume sunk revenue and profit during the fourth quarter. The brewer will also restate some past results. The maker of Molson and Coors beer said tax accounting errors in 2016 and 2017 prompted the restatements.

Traders bid up shares in Coty Inc., maker of CoverGirl, Max Factor and other cosmetic brands, after German conglomerate JAB Holdings offered to take a majority stake in the company. Coty's shares jumped 12.5 percent.

Technology stocks helped power the market's gains Tuesday. Micron Technology climbed 4.7 percent. Financial companies also notched big gains. Brighthouse Fi-

nancial surged 13.9 percent.
U.S. benchmark crude rose
1.3 percent to settle at \$53.10
per barrel in New York.
Brent crude, the standard
for international oil prices,
gained 1.5 percent to close at

\$62.42 per barrel in London. Bond prices fell. The yield on the 10-year Treasury rose to 2.68 percent from 2.66 percent late Monday.

The dollar rose to 110.52 yen from 110.40 yen on Monday. The euro strengthened to \$1.1331 from \$1.1276.

Gold added 0.2 percent to \$1,314 an ounce. Silver was little changed at \$15.69 an ounce. Copper dropped 0.6 percent to \$2.77 a pound.


