

### **Baker County Largely Avoids Flooding Affecting Neighboring Counties**

The mild storm that dumped heavy rain and melted a lot of mountain snow earlier this week has boosted several Eastern Oregon rivers above flood stage, but Baker County has fared better than its neighbors.

Flood warnings are in effect for several rivers in the region, including reaches of the Grande Ronde in Union County, the Imnaha in Wallowa County and the John Day in Grant County.

Sections of several highways were closed due to flooding as of this morning, including two stretches of Highway 26 in Grant County,

Neither of Baker County's two major rivers, the Powder and the Burnt, is under a flood advisory.

But both rivers are running relatively high due to the combination of heavy rain and balmy temperatures that accelerated the melting of a deep

snowpack.

No significant flooding has been reported, nor any water-related road closures, Baker County Roadmaster Jeff Smith said.

### 11 from BHS qualify for FBLA event

Eleven members of the **Baker Future Business** Leaders of America qualified for nationals by placing in the top four in their events at this year's state leadership conference.

The event took place April 3-6 in Portland's Lloyd Center District.

"This is the most we have ever had qualify automatically, "Toni Zikmund, FBLA adviser, stated in an email to the Herald.

Those who place in the top 10 also have a chance of competing at nationals that would be an additional eight students — if people who placed above them decide not to go, Zikmund said.

The National Leadership Conference is scheduled June 27 to July 3 at San Antonio, Texas. It will cost each student about \$1,600 to participate, Zikmund said.

# killing **legal**

Lawrence Aguilar, who lives in Pine Valley near Halfway, shot and killed a wolf on March 12 near his front door

**Baker County District** Attorney Matt Shirtcliff has determined that a Pine Valley cattle rancher was legally justified in shooting and killing one of four wolves he said were chasing his cow dog near his home on March 12.

Lawrence Aguilar, who lives about 9 miles from Halfway, said he shot the wolf three times with a .223

In a press release, Shirtcliff said that "Oregon law clearly allows the use of lethal force to kill a wolf that is biting, wounding, killing or chasing livestock or working dogs."
