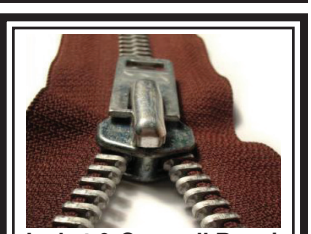

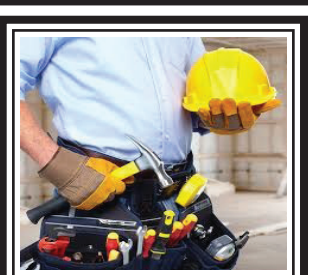

SHEEP CREEK VEGETATION MANAGEMENT PROJECT
Preliminary Environmental Assessment
USDA – Forest Service
Wallowa-Whitman National Forest
La Grande Ranger District
The La Grande Ranger District recently completed a preliminary Environmental Assessment (EA) for the Sheep Creek Vegetation Management Project, now available on the web for review. The evaluated area consists of approximately 30,000 acres of National Forest System lands on the La Grande Ranger District. The project area is approximately 22 air miles southwest of La Grande, Oregon (Townships 5 & 6 South, Range 35 East). The planning area is within Union County and contains approximately 700 acres of the Blue Springs wildland urban interface area (WUI).
