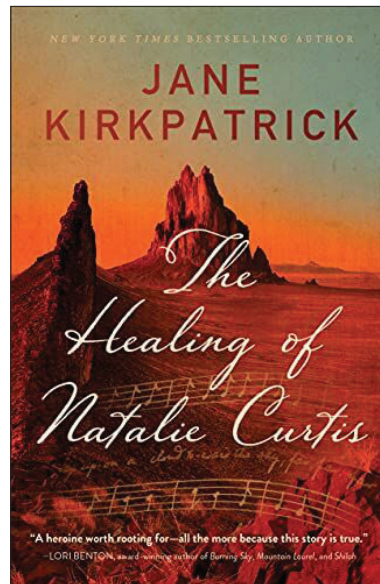
EASTERN OREGON — In celebration of Art Center East's 45th anniversary, ACE launched
