The United States Department of Agriculture Natural Resources Conservation Service (USDA- NRCS) in Oregon is considering improvements to irrigation infrastructure in Powder Valley Water Control District. Powder Valley Water Control District is the project sponsor and Farmers Conservation Alliance is assisting NRCS in this planning process. Improvements under consideration may be partially funded through the Watershed Protection and Flood Prevention Act of 1954 (PL 83-566) and will address water conveyance and operation inefficiencies in District-owned infrastructure while supporting existing agricultural land use.




