Lorenzo E. Dole, of Florence, Oregon, was sentenced to three months in the Multnomah County jail by the Federal Court at Portland on July 11, for willfully setting out fires in the forest in 1920.

This case has attracted a great deal of attention both on account of the unusual character of the case as well as the unusual character of the defendant. On May 1, 1921, a federal jury sitting at Portland, brought in a verdict of guilty against Dole for maliciously setting a fire within the Siuslaw National Forest on May 15, 1920.

From the statement of witnesses, Dole's motive of setting the fire was to clear a road for his own use and to get a burning match into his pocket.
