Even the horn did not frighten it, and finally it moved away as if there was no danger.—Coos Bay Harbor.

Coquille river harbor conditions are much improved since the work of the new government dredge which has been operating here this summer according to reports in local shipping circles. The bar and river channel have been greatly increased in depth and vessels are experiencing no delay in passing out with full cargoes.

The steamer Acme which left the Moore mill docks for San Francisco Tuesday night carried the largest cargo ever taken out of the local harbor by that vessel. It contained 482,000 feet of lumber. The fact that the vessel passed over the bar about 2-2 hours before high tide would indicate that the channel is much deeper than in the recent past. Shipping conditions are rapidly getting back to normal here.

The Steamer Brooklyn left with a cargo of lumber from the Prosper Mill Saturday night and made a record run to San Francisco.

The Elizabeth left with a cargo from the Prosper mill Monday night. Owing to the fact that her service was not up to standard for the first trip since the strike she carried no passengers but by the next trip it is reported she will again be prepared to handle passengers.

The Bandon and Acme put to sea from the Moore mill Tuesday night. The Bandon took only a cargo of lumber in the hold as she was due to take a deck load of cedar logs from Port Orford.

The Moore mill, after a delay of several weeks due to the marine strike, have resumed operations and as far as is known at this time will continue to operate indefinitely.

The Moore mill camp, also known as Conlogue's camp, at Leneve, will not resume operations until about the middle of the month. The camp has a big supply of logs on hand and will not resume until the mill catches up with its cut.—Western World.

#### Handsaker Leaves for Europe

The relief party of which J. J. Handsaker, State Director of Near East Relief for Oregon, is a member, sailed Wednesday by special relief ship from Constantinople to Batoum.

Batoum on the Black Sea is the seaport gateway to the heart of Armenia and the Caucasus region. It was at Batoum last April where just ten bags of flour remained in the whole city when the first relief ship permitted to enter for four months arrived, while at Alexandropol, one hundred and thirty miles inland, in the largest orphanage in the world, eighteen thousand orphans and seven American relief workers were on their last day of half rations, when the first train load of American flour arrived. They had been reduced to half rations for thirty days and one hundred and sixty-five children died of under nourishment during the last week.

A recent cablegram from this same section states that thirty-five thousand Armenian orphans are now being

cared for by the Near East Relief in Transcaucasia and that according to H. C. Joseph, Near East Relief director, eighteen thousand of these children are faced with the prospect of having to go barefooted during the coming winter unless timely aid arrives from America. This is a region of zero weather and heavy snow in winter.

Oregon shows may play their part in preventing such a tragedy, as Mr. Handsaker will spend the summer in relief work and expects to distribute personally many of the supplies contributed by Oregon friends to Near East Relief.

#### Fined \$10 for Assault

J. L. Holycross was fined \$10 in Recorder Lawrence's court last Monday for assault and battery on the person of Lyle Stebbins Saturday afternoon. Stebbins was also on trial for fighting and disturbing the peace, but as the three witnesses called all testified that Stebbins had not struck a blow the judge could do nothing else but discharge him. The fight started in front of Holycross' cigar store Saturday afternoon, but as Stebbins would not fight in town the affair was adjourned to a point outside the city limits. Holycross got the better of it there and Stebbins cried enough.

Week before last, when Holycross was in Bandon, Stebbins had been left in charge of the former's place with strict injunction to allow no booze in the place. Twice Holycross came back unexpectedly and he asserts that his orders had been violated. Once he threw Stebbins out of his store and the statements by the latter that he was selling booze for Holycross caused the ill feeling on the part of the latter. It was remarks of that nature which caused Holycross to assault Stebbins last Saturday.

#### "Battle of the Argonne"

On the last night of the Ella state convocation at Marshfield there will be one of the greatest outdoor spectacles that has ever been seen in this part of the country. It will be the big war spectacle "Battle of the Argonne," which will be given under the auspices of Coos Bay Post No. 17, American Legion, and R. P. O. E., No. 1160, in conjunction with the 2nd Company, Coast Artillery. The date is Saturday night, August 20th, at 8:30 p. m. Two hundred Coos Bay veterans will enact battle scenes.

An airplane, piloted by Aviator Briggs, will fly over the heads of the men depicting the battle, dropping bombs and looting fares. The plans will do acrobatics and maneuvering, such as was used over the battlefields of France. The plans will be illuminated by a special pyrotechnic preparation, so that it can be seen at all times. Aviator Briggs is a former army flyer and this a big feature in itself.

After the battle scenes have been enacted, there will follow a full hour of the most wonderful fireworks that have ever been presented on the Pacific coast. This will include a reproduction of the "Siege of the Dardanelles" by the British fleet, a mechanical wonder of modern pyrotechnics. It will show three big warships destroying a fort and blowing up a submarine. Besides this, there will also be shown many beautiful set pieces, covering an area of several hundred square feet, with such novelties as "Jiggs and Maggie," Ella emblem, American Legion emblem, huge American flag, Aladdin's jewel case, an American doughboy, booster motto, hundred of rockets, bombs, aerial parachutes, balloons, motor fire, sky glares, and beautiful shells that throw myriads of colors in every direction across the sky. All these big features will take place on the fair grounds, and it will be necessary to get tickets early as the crowds that will view this marvelous production will number up into the thousands. The different committees have advised those who want to see this extravaganza to get their tickets at once and avoid all delays in combating the huge crowd that is expected.
