### Death of Jas. W. Hammack

James W. Hammack, of Fishtrap, died at the Fishtrap hospital at Myrtle Point last Friday morning of typhoid fever and was buried at Fishtrap Sunday afternoon at 3 o'clock. His wife and oldest daughter are also down with the same disease and were not able to attend the funeral. Mr. Hammack and his family recently returned from the Willamette valley, near Corvallis, but whether the disease was contracted out there or since their return is not known.

The funeral services were in charge of Elder C. H. Barlow, of the United Brethren church at Myrtle Point, of which Mr. Hammack was a member. The services at the grave were conducted by the Coquille Odd Fellows lodge of which the deceased was a member. A very large assemblage was present for these services and the grief of friends and neighbors testified to the high esteem in which he was held. Upright and honest in all his dealings, he was respected and liked by all who knew him.

James Wesley Hammack was born on Fishtrap, Aug. 14, 1899. In September, 1914, he was married to Miss Camie Royer. To this union two daughters were born—Mildred Lena and Estella Alberta. He leaves besides them, his father, W. M. Hammack, a sister, Mrs. Nile Miller, two brothers, Ernest and Emmett, and a great many other more distant relatives.

### Is the Fair Advisable?

According to C. C. Chapman in the Oregon Voter, if the 1925 fair is held in Portland at a cost of \$6,000,000, Coss county's share of the \$1,000,000 which it is proposed to raise by taxation outside Portland, would be \$68,598. In addition to this there would be the added expense for exhibits—county, municipal, industrial, school, etc. There is no question but that if the fair proposition is put through there will be a frenzy of money spending during the next three years that will jax up every industry in the Pacific Northwest. But what will be the effect in 1928 and thereafter, if what the Voter asks. Are the taxpayers of Oregon in a position to gamble from \$6,000,000 to \$15,000,000 on the chance that the fair will bring prosperity to Oregon, which will reimburse them for the cost?

The editor of the Voter is taking a brave stand when he throws out these sober-thoughts ideas in the face of the great popularity of and enthusiasm for the event. There are always knockers for every progressive move but Chapman is not a knocker. He is always a booster and his thoughtful article is going to be seriously considered, even though the final decision is for the fair. We can pay the bill if we are going to get value received, but can we afford it for a joy ride and a jazz party?
