### J. P.'s Met Here Wednesday

The Justices of the Peace county organization met here Wednesday morning to discuss matters pertaining to the duties of their office and to agree on uniformity of action. The principal matter considered was that of issuing search warrants. The state's code requires that depositions, showing probable cause, must be taken from the complainant before a search warrant can be issued. This has not always been done in the past. This has not strict Attorney Bedingfield met with them and gave his opinion as the legal requirements.

Immediately afterwards the Officers Law Enforcement Association formed a permanent organization by the election of Deputy Sheriff Malehorn, as president; Marshal F. R. Jackson, of North Bend, as vice president; and J. J. Stanley as secretary-treasurer.

### It Is Fishermen's Friend

Killing off the sealions is a mistake and to pay out public money for the purpose is like paying a man to cut your own throat, thinks Sam Nass, who operates the Prosper Cannery company on the lower river. He believes that the sealions are responsible for chasing the salmon into the bays and rivers; if there were no sealions there would be no salmon. "Of course," he says, "the sealions destroy some of the fish but we get some of them too. Let the salmon remain out in the ocean and nobody will get the benefit of them. The state should spend its \$40,000 a year to some advantage rather than to injure the industry it believes it is protecting."

Mr. Nass states that he started out in the fishing business 35 years ago on the Columbia river. At that time there were more sealions and bigger packs of Royal Chinook than has ever been had since. The same, he says, is true on the coast of Norway with the herring and the whales.—Bandon World.

### RETURNING TOURISTS TELL SAME STORY

"One of the greatest encouragements in the eight years I have served as Director of the Near East is the report brought back by returning tourists this year," states J. J. Headaker, Regional Director for Near East Relief for Oregon, Washington, British Columbia and Alaska.

"It is a very significant thing that these tourists all come back with the same story. Some saw one part of the work and some another. But all unite in saying that the Americans engaged in the work are of unusually high type; that the work is economically and efficiently done, and if America only knew the need and how far the need is being met with the money available, there would be no lack of funds."

"Among those recently visiting the Near East and whose reports have been uniformly enthusiastic, are Mrs. C. S. Jackson and her secretary, Miss Julia Hobday, of the Oregon Journal; Miss Cornelia Marvin, State Librarian; Mrs. Louise Kellems, of the Eugene Bible University; Prof. W. J. Sly, Linfield College; Miss Melia Smith of the Portland Public Schools, and Dr. and Mrs. H. W. Coe of Portland, philanthropists, Dr. J. R. Wetherbee, former President Portland Chamber of Commerce.

"Acting on the advice of the National Information Bureau, the Community Chests of Portland, Tacoma and Seattle include the Near East Relief for generous appropriations. The purpose of this bureau is to investigate the workings of relief agencies, both at home and abroad, and no Community Chest will give a penny to an organization not approved by this bureau. Investigators have found that the money gets there—if we give it."

### Teach Young Bull Calf

### 'SEND ME BACK' PLEADS THURBER

"All I ask of the American people is that they will send me right back into the midst of it all again. I want to be out in Greece taking the motherless children out of the leaky, desolate camps and placing them in homes of comfort," says Christopher C. Thurber, who is spending the early weeks of December in Oregon and Washington as speaker for Golden Rule Sunday, December 7th.

During his five years in Turkey, Thurber lived through more experiences than would come to the average person in as many lifetimes. He was imprisoned by the Turks for four months because he would not pay his income tax—a tax larger than his whole income.

One night, while alone in his office he was suddenly summoned to the Turkish headquarters, where without ceremony or explanation, he was beaten into insensibility. The soles of his feet were mashed to a pulp, his ribs crushed, and his face was almost unrecognizable, when, after a night of insensibility he was found the next morning by the other Americans.

Later, while taking children from the bodies of their dead mothers, an infested louse crawled from the body of a child to Thurber's body, and for days he was delirious with typhus.

"The thing that caused me to lose faith in God, and man and everything and everybody, was the order from New York saying that since people in America were getting tired of giving, we must take in no more children. Four thousand children presented themselves in a period of a little over a year. They were the remnants of 280,000 people driven past my relief station during the last three years, not more than 30,000 of whom survived. How could I refuse those children? I couldn't! I took them in, and I fed them. We cut all our rations to two meals a day, and that was black bread and water. But we saved the children."

When the orders came from the Turks that even the children must leave Turkey, Thurber was 200 miles from the coast, with three ranges of mountains between him and safety. It was in the dead of winter, with deep snow everywhere. There were neither railroads nor automobiles, and the 1,000 children were transported in relays on the three weeks' journey to the sea. Many died enroute, as frequently there was no shelter either by day or night and they had to sleep in the open in the snow. When finally they reached the coast and saw the American flag flying over the ships brought for their rescue, and the white-coated sailors tenderly lifting the little children to places of safety, some came to him and asked, "Where is God?" Naturally they thought they had reached Heaven.

When Thurber arrived in Constantinople he found thousands of people huddled in the great Selimie barracks in Constantinople; the barracks in which Florence Nightingale immortalized herself a few generations ago. Typhus, typhoid, smallpox, diphtheria, scurvy, were only a few of the diseases taking heavy toll of human life. Thurber bought cabbage for the carload to break the scurvy; but when even carloads were not sufficient to give the necessary green foods to the scurvy sufferers, he bought a field of grass and with that broke the disease. He stayed in Constantinople until Greece again opened her gates and allowed the remaining refugees to find shelter in her borders.

Thurber hopes, after visiting Oregon and Washington, to return again to the camps in Greece, where he says there are at least 35,000 orphan children, many of whom must die this winter from sheer exposure.

### HAWAII RAISING FUND FOR GREEK REFUGEES

Honolulu.—Under the leadership of Governor Raymond C. Brown says: "America's work in the Near East is a symbol, not of the political and commercial America, but of the idealistic and humanitarian America.
