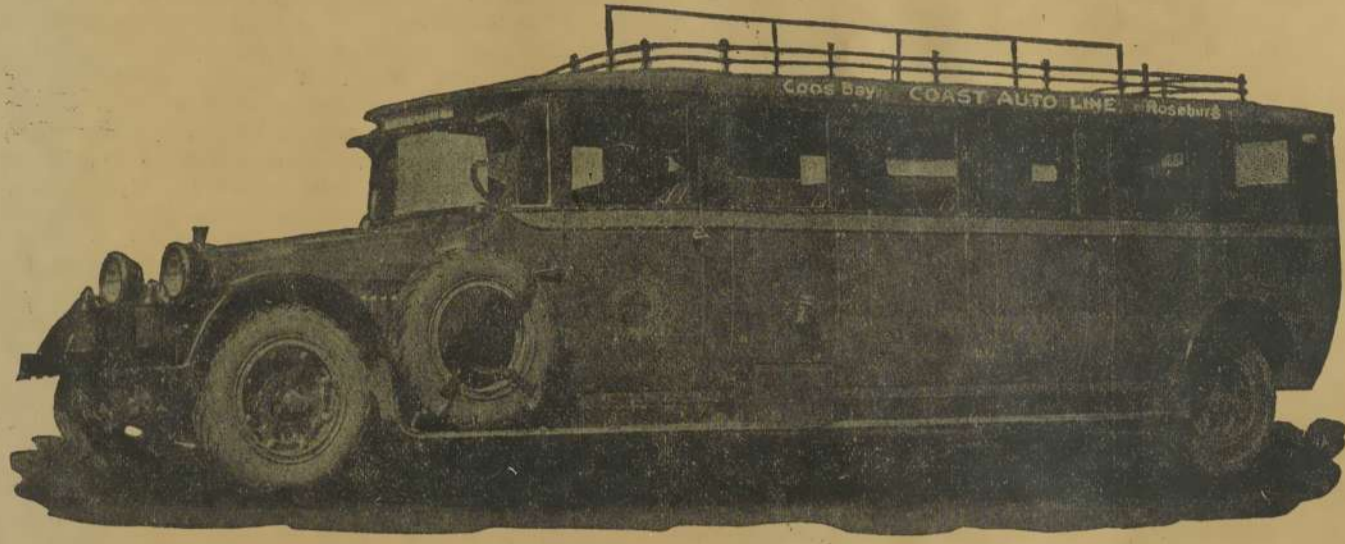

In the matter of transportation Coquille is most fortunately served by the Coast Auto Lines, which radiate out of Coquille in every direction connecting Coquille with all of the surrounding country and affording two major connections with the north and south coast highway service and direct connection with California via Crescent City.

Coquille is the headquarters of the company which is under the direct personal supervision of that genial Coquille citizen and booster, George W. Bryant, the general manager of the company.

The transportation service roughly covers the following scheduled lines: Marshfield, Myrtle Point and Roseburg, Bandon, Gold Beach, Brookings, Crescent City, California, to Grants Pass, Oregon, hourly service being maintained between Coquille and Marshfield, and three round trips daily being made to Roseburg with daily trips to Crescent City and from Crescent City to Grants Pass. Close connection is made at Roseburg with both trains and stages going north

to Portland and southbound. Connection is also made at Crescent City, with through stages to San Francisco and Southern California points.

The equipment used on the various lines operated by this company are to the last word modern and are such as cater to the comfort and absolute safety of the company's passengers. Facilities are also furnished for handling traveler's baggage in conjunction with the passenger service, and, notwithstanding the dangerous condition which often prevails during the winter months on the roads traversed by the company's stages, the company feels great satisfaction and pride that they have not had a single accident, in which any passengers have been seriously injured, even though their drivers have had at various times strenuous work in bringing through their stages. In the main the stages of this company are held to a very close schedule which is maintained on time. The remarkable absence of accident is due not only to the fact of the excellent equipment

maintained by the company and its exacting inspection and maintenance effort, but is also largely due to the personnel of the company's employees, the drivers of the stages. The drivers are in every instance chosen as men experienced and mentally qualified to look after the safety of the passengers and their property.

The contact between manager Bryant and the employees is such as to stimulate in each employee a feeling of responsibility and a knowledge that carefulness and conscientious service will always be recognized and commensurately rewarded. The feeling between the employees and George Bryant is not that of the employee and employer, but is rather that of business associates and personal friends.

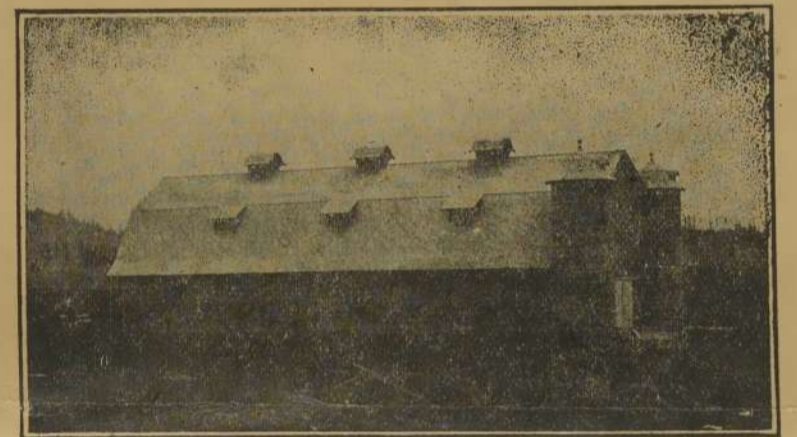

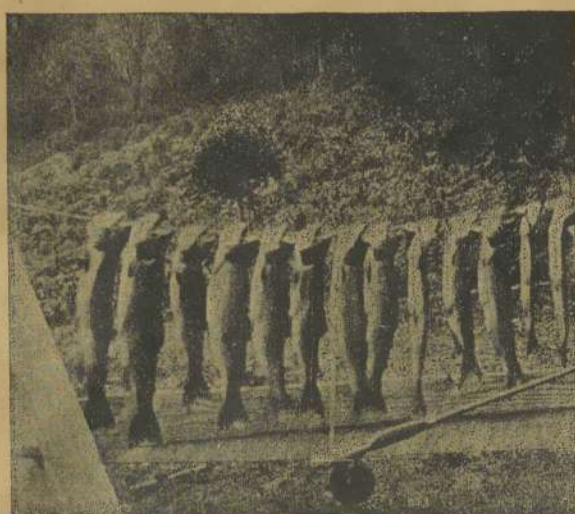
