About 25 students are turning out for daily practice and if their weight was in accord with the spirit shown, Coquille would have another championship team this year.

Of the twenty-five there are just eleven who were in the squad last year—Lester Wilson, captain, Wayne Robinson, Hadley Curtis, Royce Richmond, Zed Finley, Harlo Call, Herman Ploen, Harry Mast, Rupert Pownder, John Seeley and Clarence Barton.

Chet Stonecypher will return to school in a week or two but as he is going to undergo an operation on his tonsils, it is doubtful if he could get into the game until the latter half of the season.

Several of the boys who are turning out for the first time this year are showing up well and "Brick" is counting on a pretty fair team for the first game, which will be played at Myrtle Point, Oct. 3, but he doesn't know what he will do for substitutes in case of injury.

Contrast with this paucity of material the condition at Marshfield where 86 boys turned out to try for the team.

Legion to Participate

Carl Mosier, State Adjutant of the American Legion of Oregon, was in Coquille Thursday night and met a dozen or more members of the Coquille Post. The purpose of his visit to this section was to find out what was wrong with the American Legion in this part of the state in regard to the National Endowment Fund. This is a fund of \$5,000,000 that is being raised by the Legion to care for the children of disabled veterans and orphans of veterans.

Mr. Mosier stated last night that Portland had raised over \$40,000 toward the fund and were giving a big boxing show soon to add to it. Marshfield has just raised \$1100 by subscriptions. Of the 120 Legion posts in Oregon, all but six have done their part toward the drive, and in the six are Coquille and Bandon. The state department wishes to be able to make a report to the big national convention at Omaha next month.

At a dinner at the Coquille Hotel last night the local post enthusiastically voted to put on the campaign in the near future. An organization has been completed and the local post has taken as their slogan—"Take Coquille out of the Inactive Six." If there are posts in Oregon who do not make an effort to help, Coquille won't be in the list.

Later reports from Mr. Mosier state that a large meeting was held in Bandon last night, and arrangements made to put on a drive there next week.

S. E. Aasen's Sea Voyages

Capt. S. E. Aasen, of Norway, who was a caller last week, told us about being adrift at sea north of Norway in 1898, when he was a second mate, when he saw 160 vessels crushed in the ice there. After that he went from Archangel to Kadiostock with a lumber cargo by way of the Cape of Good Hope. On his return trip he went across the Pacific to San Francisco, thence around the Horn back to Norway, thus completing the circuit of the globe. Mr. Aasen, who was born in 1846 is expecting to celebrate his eightieth birthday next year.

Morrison Heads Health Assn.

The annual meeting of the Coos county public health association was held here Tuesday and outlined the program of that body for the coming year. The object of the association is to co-operate with the county health officers and the county nurses in the work they are doing throughout the county. There were thirty-five people present at this meeting, including Mrs. Sadie Orr-Dunbar, of Portland, executive secretary of the state tuberculosis association and president of the Oregon federation of woman's clubs, who was the principal speaker of the meeting. She indicated how she thought the work of the association could best be accomplished and urged that the community groups of the association arouse interest in public health measures in their home towns and hold several meetings a year to keep the public interested in health measures.

The following were chosen as officers and community chairmen for the coming year:

A. T. Morrison, president; Mrs. E. J. Loney, of Powers, vice president; Mrs. A. E. Elder, of North Bend, financial secretary; Mrs. Chester C. Farr, of Coquille, recording secretary; and Mrs. Ida K. Owen, of Coquille, treasurer.

Community chairmen: Mrs. T. H. Temple for Marshfield; Mrs. Curtis Townsend for Coquille; Mrs. William Neilson for North Bend; Mrs. G. H. Noeler for Myrtle Point; Mrs. Gamwell for Powers, and Mrs. Thomas Robinson for Bandon.

The following committee chairmen were selected: Dr. Everett Mingus of Marshfield, advisory committee; Mrs. W. E. Couper of Marshfield, supply committee; Mrs. J. E. Mills of North Bend, nurse committee; Mrs. Del Whitaker of Myrtle Point, educational committee; and Mrs. Alice Maloney of Marshfield, publicity committee.

At this meeting each committee chairman made a report. There were present Dr. Kennedy, of North Bend; Dr. Drake, of Coquille; Miss Ella Horn and Miss Mabel Ejsaman, county health nurses; and A. T. Morrison, county juvenile officer.

Powers Health Report

Amount netted by membership drive for Coos County Health Association in November, was \$29.50, of which \$14.75 was sent to the association and \$14.75 was kept for work in Powers.

Sale of Christmas seals amounted to \$76.60.

At Christmas, baskets of food and clothing were distributed to needy families.

In January, \$5 was given toward providing braces for a local boy in order that he could become self-supporting.

In February, we were the means of placing an aged woman, suffering from an incurable disease, in the county hospital.

Minor cases were taken to the local doctor and treated by him.

Dr. Milne, dentist, gave his services free in attending to the needs of a boy suffering from malnutrition and defective teeth.

Much credit is due to the grade teachers and physical director in following up cases of underweight children, and for the interest manifested in the making and studying of food and health posters.

There is now \$8 in the fund here at Powers, against which there is an outstanding bill for dental supplies. Respectfully submitted—Mrs. J. W. Gamwell, community chairman.

County's August Expenses

Road warrants authorized by the county court early this month in settlement of August claims against Coos county were nearly 25 per cent greater in amount than they were in July. The August first payments totalled \$59,686.02, while those of September 1 aggregated \$72,396.28.

The last mentioned figure is composed of the following items of expenditure:

General Road Fund, \$34,614.86.
Market Roads, \$15,376.19.
Special district funds, \$19,079.00.
Maintenance, \$1,163.07.
Myrtle Point-Sixum market road, out of the recently voted bond issue, \$500.78.
Big Creek road, out of the same fund, \$1,612.38.

Road payments will not be anywhere near so large for the balance of this year as the Wilkins contract at Lakeside, and the Peart contract at Fairview were fully paid up the first of this month.

The general fund payments this month totalled \$40,135.18. This account usually requires \$12,000 or \$13,000 a month to liquidate but in the August bill allowed there were two large items. One was for \$23,661.65 in the Oswald West case, including counsel fees; and the other was for \$4700.89, tax rebates of penalty and interest on the 1921-22
