### ROOSEVELT HIGHWAY TRAFFIC

In a communication to the Oregon Voter Joe Dunne sneeringly suggests that "the engineering corp of our national guard take a week and construct a pontoon bridge that will suffice for the 250 or fewer cars that now use this road (the Roosevelt Highway) daily."

Not to answer Dunne, who is already done, but to give a correct light on the use of the Roosevelt Highway, the Sentinel editor counted for 30 minutes the cars which crossed the Floras creek bridge south of Langlois. There were 42, or a total of 840 for a ten-hour day.

When the Rogue river bridge is built and the highway oiled its entire length there will be more cars travel that highway an hour than Dunne falsely states now use it during a day.

### THE ADVANTAGES OF AGE

"Many of the highest positions are held by men past fifty," observed the National Home Study Council of Washington, D. C., in commenting on the advantages of age.

"The years bring advancement and progress," the Council continues, "when they are spent in study and directed toward some goal. The rapid and widespread development of home study in practically every field now makes it possible for men and women to continue their studies indefinitely beyond the period of formal schooling."

"When President Hoover chose his Cabinet, presumably the ablest counselors he could select from our population of 115,000,000 he picked men whose ages average well above 60—the youngest is 54; the oldest 75."

"So it is in all walks of life and in all lines of business and the professions. All talk to the contrary is doing a grave injustice to the rising generation. The young man who thinks he has 'arrived' or that he will 'arrive' this side of 50, is the man whose development is probably already arrested. He is the fellow who will be punching the time clock for his more modest rival when he is 35, and will probably be in the discard at 45."

"This generation needs mature men of power. The next generation will experience the same great need. The world is not becoming a simpler problem, but rather more complex and difficult. You can grow a pumpkin or a 'bumpkin' in a few weeks, but it usually takes at least fifty years to grow a real man."

### Watch for Tagged Steelheads

Sportsmen who fish the Rogue River are being asked to co-operate with the state game commission and the federal bureau of fisheries in obtaining results from the marking of Steelheads that is now going on. Those who catch these trout, carrying a tag on the upper part of the tail or Caudal fin are asked by Matt Ryckman, superintendent of hatcheries to save the tag and send it to the state game commission along with the size of the fish and the locality from which it was taken. Every two weeks 200 steelheads are caught, marked and then released, and their progress up the Rogue as well as their habits are being carefully checked. C. E. Miller, of Portland, a member of the state game commission, has a cabin on the lower Rogue and he is daily catching steelheads with hook and line, marking them and then turning them back into the stream.

Numerous inquiries have come to the state game commission relative to the herd of elk in Klamath County near Crater lake. The start of the herd, 12 cows and bulls, were purchased in the Jackson hole country of Wyoming in 1913 and for a time kept on the Big Hilly Meadows game farm. They were eventually released in Klamath county and the herd now numbers more than 100.

And will she blush? Well—she ought to because every delegate, married or single, at national V. F. W. encampments for the past ten years, has made love to Kittie Mulhall, long since recognized as the "sweetheart of the V. F. W."

Kittie Mulhall's popularity in veteran circles is bounded only by the coast lines of the country. She is known to more ex-service men than General Frank T. Hines would suspect he has on his rolls at the Veterans Bureau.

But Kittie's only love has been the welfare of disabled war veterans and their comfort in the hospitals. She has been head of the V. F. W. welfare work in various hospitals near Chicago so long that memory of man runneth not to the contrary.

She has distributed more cigarettes to hospitalized veteran patients than the vast number that have appeared in newspaper blindfold contests.

Stationery, comfort kits, and other necessities that hospital facilities fail to provide have been scattered like sunshine throughout hospital wards by the truckload, all due to the genius of this Chicago lass whose heart and soul is devoted to the welfare of the ex-service man.

Kittie Mulhall loves the ex-service man for many reasons. But primarily there is one reason that explains her devotion. Kittie's brother, a big strapping youngster, was killed in action overseas during the world war. And Kittie can't forget.

In tribute to Miss Mulhall's popularity, the convention committee has completed all arrangements for a wedding that will be attended by those who know and love her best—her friends of the V. F. W. from all over the country.

After the words that take Kittie Mulhall from the arms of thousands of her doughboy friends and give her into the keeping of one are pronounced in St. Paul's Cathedral on August 26, the wedding procession will file out beneath an archway of flashing sabres held aloft by members of the Officers' Reserve Corps.

The bridegroom? No—not forgotten but merely accorded the prominence in this story that a bridegroom usually enjoys at his own wedding. He is Charles V. Nolan, of Clifton, Kentucky, and of course, a former doughboy.

They met just as you would expect a girl like Kittie Mulhall to meet her future husband. It happened in 1919 at Fort Sheridan hospital, in Illinois. 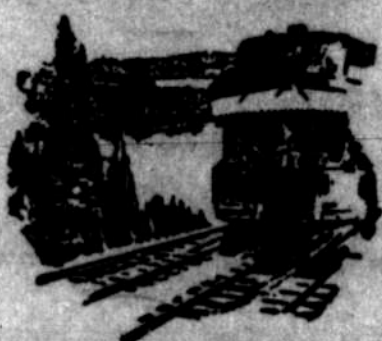
