Gov. Meier Appoints Coos Committee on Unemployment

Coos county's unemployment problem and the task of providing food and shelter for destitute families has been entrusted by Governor Meier to a committee composed of Judge D. F. Thompson, of Coquille, and Mair A. Dano and L. L. Thomas, of Marshfield. This committee which will function as a part of a state-wide organization, will form the nucleus of an organization to be formed in the county to cooperate with the county court and city officials in meeting the local situation. Similar committees have been named in every county of the state and the governor has appealed to the people of the state generally to "join together" to the end that "no family in Oregon shall lack for food and shelter."

"In common with the other states of the union Oregon is confronted with an unemployment crisis due to the world wide economic depression," the governor declares in his letter to the county committees. "To meet this serious situation the state and each one of its political subdivisions must begin now to formulate plan for unemployment relief during the coming fall and winter."

Registration of the unemployed in each community is suggested by the governor as a means of affording systematic relief. While the governor frowns on expenditures from the public purse for projects except such as are permanent and necessary, he suggests that in any work of this character which is undertaken, labor-saving machinery be dispensed with so far as possible in order to afford employment to the greatest number of people.

"Rules and regulations should be formulated as to length of required residence in the county and a policy should be established regarding preference for men with dependent families," the governor declared. "Cooperation should be enlisted from civic organizations and the citizens of your community in listing employment."

"Rules might be made for the acquisition of surplus food stuffs and for an efficient method of purchasing, storing and distributing necessary supplies. In a land of plenty, like Oregon, where fruit and vegetables go unharvested each year no man, woman or child should suffer the pangs of hunger, nor should any family be exposed to the rigors of winter for want of shelter."

State Fair Opens Sept. 26

New features, new buildings, new exhibits, and the old familiar favorites of bygone seasons better than ever.

This is the promise of Max Gehlhar, director of the department of agriculture, for the 70th Oregon State Fair, which opens Saturday, September 26, to remain open for nine continuous days until October 4.

Premiums of \$60,000 are offered for thoroughbreds of the finest breeders in Oregon, the Pacific Northwest, and other states.

A. P. Fleming is again in charge of the classic night horse shows. The racing program for both harness and running horses promises to be the best in the Pacific Northwest this season. Under expert care the fairgrounds half-mile track improves each year.

The Rodeo Buckaroo, which runs the first three days of the fair, features stage coach races, chariot races, calf roping, steer bull-dogging, and bronco busting.

A new attraction of state-wide interest is the First Oregon State Fair Band Contest, for community, municipal and private bands. Director Gehlhar has provided \$2,000 in cash prizes, to go for the best bands, and the best band stunt costumes. Entries are already indicated from eastern, southern, central, and Willamette valley sections of Oregon.

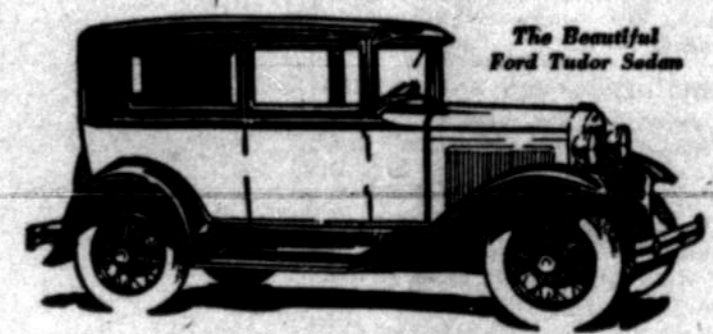
