She reported new growth appearing and naturally felt much elated. Some people report the loss of their fish while others say theirs came through safely. Bulbs, glads, and dahlias seem to have suffered greatly and sweet peas were also killed, which is very unusual in this country. Let us hope it will be fifty years again before we get such another freeze.

Our program was short Tuesday night, Mrs. Beyers not having had time to prepare a more extensive one; but I am sure all present enjoyed what she had. For the first, she displayed what might correctly be called a floral map of the United States. It was a large map with the different states in colors. On these were printed, in their natural colors, the state flower and an accompanying description told whether the flowers were adopted by the vote of the school children or by the legislature. It's a very oddity, as well as beauty and educational value, made it a prize worth

having and after the meeting Mrs. Beyers presented it to Mr. Taylor. Another prize picked up by Mrs. Beyers while in Portland last week, was a book by A. C. Hottes, associate editor of "Better Homes and Gardens," it is called "1001 Garden Questions Answered," and covers all phases of gardening and garden troubles in an extensive and concise manner. As no contest for the cup had been arranged for that night that part of our work was dispensed with, but at our meeting of January 17, winter bouquets of any kind or description and in any kind of container are to be the contesting features.

And for our meeting on February 7th, cut branches of dormant fruits or flowering shrubs which have been brought into the house and forced into bloom are to be used for the cup contest. This ought to be very interesting as there are a number of different flowering shrubs which can be used and we all know and use the pussy willows. You will have four whole weeks between meetings for this contest, so see what you can do. I am sure some of you will be very much surprised at what you will find out. In the January, 1933, number of "Better Homes and Gardens," under the title of "The Diary of a Plain Dirt Gardener," there are mentioned numerous flowering shrubs that may be used for this purpose. You will find it on page 31 under the day of January 14. It also tells how to prepare the branches for the water. In the Dec., 1932, number of this same magazine, under the heading of "The Juniors Prepare for Christmas," is shown a carrot growing in water and on page 44 of this same number it tells how to grow these and other things in the same way. This part of the article is called "Winter Garden Gifts." Now you will have something new to try. Those of you who are interested in dish gardening would probably be interested in another article in the Jan., 1933, "Better Homes and Gardens," it is called "Then I Met a Lady Who Owned a Glass Garden." For those who love to grow things, but whose condition of living prohibits it, this article will certainly appeal to them. Be sure to get your flowering branches ready and bring them to the club on February 7th. Don't forget the date and also don't forget to attend the next meeting, January 17, at 7:30 p. m.
