State Capitol News Letter

Much legislation affecting county governments will be considered by the lawmakers of Oregon at the present session. Some of the proposals are still in the nebulous state while others have already found concrete form in the shape of bills which have been introduced into the legislative hopper.

Probably the most revolutionary proposal yet advanced is that of Senator Woodward who wants to consolidate Oregon's 36 counties as now constituted into, not to exceed nine. The senator from Multnomah county has not ventured to suggest any specific changes in present county lines, choosing rather to leave that delicate task to the lawmakers or at least a committee and confining his suggestion to the general proposition of county consolidations. When he attempted to enlist the support of the joint ways and means committee for his suggestion he found little enthusiasm there. Several of the committeemen agreed that the proposed consolidations would be brought about "eventually" but evidently regarded the problem as too hot to handle just now, what with other matters such as balancing the budget, raising revenues etc., pressing for immediate attention.

Then there is the proposal of Senator Upton that the counties be placed under a managerial form of government. Under this plan the present set-up of officials—clerk, recorder, sheriff, assessor, school superintendent and commissioners would be abolished. Business of the county would be administered by a non-salaried board of five members who would employ a manager as the executive head of the county organization. The county manager would be authorized to employ such assistance as might be necessary in performing the various functions of county government.

Several proposals are floating around which have for their purpose the extension of financial relief to counties. Many members of both houses insist that any new tax program which may be adopted at this session must take into consideration the serious plight of the several counties, many of which are facing bankruptcy because of heavy tax delinquencies due to a breakdown in the property tax system. Some legislators who have expressed themselves as opposed to the principle of a sales tax have said that they would be willing to vote for such a tax as a strictly emergency measure pro-

viding the lion's share of the revenue from such a tax went into the treasuries of the various counties. The so-called "shelter exemption" sales tax, sponsored by the Jackson county delegation in the house, imposes a tax of three percent on gross sales, two-thirds of which would go to the counties and one-third to the state. This, however, would not materially benefit the financial position of the counties since any sales tax revenues received under the provision of this bill would only affect property taxes lost to the counties and school districts by reason of the homestead exemption provision which exempts home owners living in their own homes from property taxes up to a maximum of \$1,500 in assessed valuation.

A bill which would require the state to share in tax delinquencies has been introduced into the Senate by Senators Zimmerman and Burke and Representatives McPhillips, Lewis and Dueret. Under the terms of this measure the county treasurer would only remit to the state its proportionate share of taxes actually collected. Under the present law the state's levy must be paid in full by the several counties regardless of the fact that only a small percentage of the tax may actually be paid by the property owners.

Legislators are not inclined to take seriously the proposal of Representative Cordon that local tax levies be arbitrarily slashed twenty percent through a legislative mandate. While it is believed that such a cut could be applied to many local levies without harmful effect the lawmakers point out that it would be unfair and unjust to apply such reduction to the budgets of these counties, school districts, cities and other subdivisions which have already pared their expenses to the bone.

Those who point to the governor's veto of the property tax repeal bill and declare that the state's financial problem is now right back where it was before the special session met overlook the \$10,000 appropriation bill passed by the legislature and signed by the governor covering the expenses of the extraordinary session.

Probably the most interesting development in the present legislative session, at least from the political standpoint has been the outbreak of hostilities between Governor Meier and State Treasurer Holman. These two, once, and only a few months ago, fighting shoulder to shoulder as members of the board of control are now at swords' points and overlooking no vulnerable point in the armor of each other in their determination to implant a vital thrust.

While the two officials have been engaged in sniping at each other on and off the board of control for several weeks neither had openly attacked the other until last week. Among lobby loungers around the capitol corridors it was generally remarked that the state treasurer was being omitted from the conferences on state finances which were being held in the executive office, although the problem in hand most immediately concerned the head of the treasury department. Then the governor sent

the warrant bill back to the legislature with his veto indicating that a substituting measure would be introduced in the regular session. That might not have been so unusual and would probably have escaped comment except for the fact that it was pretty well known that the governor's principle objection to the bill was based upon its parentage, the measure having originated in the treasury department. Anyway the governor told legislators, in no uncertain terms, that those who had voted for the bill under the impression that it was an administration measure were in error and adding that when the administration measure did make its appearance it would impose responsibility for the issuance of state warrants on the three members of the board of control rather than limiting that authority to the state treasurer.

Then the battle was on. In statements to the press and the lawmakers Holman has pointed out a number of alleged weaknesses in the governor's political armor. For instance he has pointed out that the budget of the governor himself was one of the few that called for an increase in appropriation over that of his predecessor whereas the governor has persistently demanded cuts in the budgets of all other state departments and institutions. Again he has called attention to the possibility of eliminating the office of budget director, now held by Henry Hansen, an appointee of the governor. And last, but by no means least, he has suggested the advisability of investigating conditions in the board of control office where, he charges, the domineering attitude of William Einzig—also a Meier appointee—has resulted in the perpetration of a "reign of terror."
