Washing Machine Returned Before Theft Was Known

Coos Bay Lumber Co. Camp at Fairview This Winter

of which is now being seriously discussed, would result in a considerable increase in sales and subsequently necessitate a sharp advance in logging activities.

"Our fir log requirements for our current rate of lumber production, plus our sales of logs for export, are from 12 million and 15 million feet per month, in addition to incidental production of Port Orford cedar logs," the company's president declared.

"Our Eden ridge operations are now running at present installed capacity, with more than 450 men steadily employed. We feel that we should not have to depend entirely on that one source of supply, because a fire, slide or storm might shut off our complete supply of logs, and therefore throw all our men out of work, at least temporarily."

Mr. Bunker pointed out that previous attempts to purchase necessary land had failed, but if the present attempt meets with success he announced his company would start immediately to construct a continuous railroad leading from the S. P. tracks. Upon completion of the road to the timber stands, the firm anticipates resuming logging operations east of Coquille, which were suspended three years ago when the company's old railway became beyond repair.

No estimate of the possible payroll or the number of men to be employed was announced officially.
