Carl C. Donagh Announces for U. S. Senator

Following is the statement by Carl C. Donagh, released last Sunday, in which he announces his candidacy for the office of U. S. senator:

In response to the repeated requests of citizens from all parts of the state, I have decided to enter the May primaries as a candidate for the democratic nomination for United States Senator from Oregon.

Oregon has shared liberally with the rest of the nation in the benefits of the president's comprehensive program. The Bonneville project holds great promise for this state, and the development thus started on the Columbia must be continued. The future of this region will be determined to a large extent by what we do with the Columbia and its tributaries, including the Willamette. These natural resources must be utilized for the benefit of all the people.

We must press our demands upon the federal government for adequate defense facilities at Fort Stevens and Tongue Point.

I will continue my whole-hearted support of the president of the United States.

In due course I intend to present clearly to the people of the state my attitude on the pertinent issues. When I begin my campaign I shall take a leave of absence without pay from the office of United States Attorney, which I now hold, so that I may devote my time to visiting all parts of the state and discussing with the people the local problems in which a United States senator can be of assistance.

Two Damage Suits Won

The jury in the Laura Prince vs. W. W. McDonald damage case brought in a verdict last Thursday afternoon in favor of the plaintiff, for \$1961. She was injured by falling down the chute at the McDonald Candy Co. place of business.

The case of Della I. Guedon, who was suing P. J. Rooney Auto Co. and Norman Wilson for \$10,513 for injuries received in an auto accident in September, 1936, was started in circuit court last Friday, and was completed when the jury brought in a verdict for Mrs. Guedon in the sum of \$9,346.64 at eight o'clock Tuesday evening. Much of the time was spent in the attempt to prove that Wilson was not employed by Rooney at the time he collided with the Guedon car and Mrs. Guedon was injured, but the jury held both Rooney and Wilson to be jointly liable.

Mrs. Ray Had Lived in Coos County 41 Years

Mrs. Fannie Ray, widow of the late Calvin J. D. Ray, passed away at 2:00 a. m. at the Mast Hospital in Myrtle Point after five days illness from pneumonia.

Mrs. Ray was 75 years old and came to Coos county from Kansas in 1896. The family lived near the mouth of Coos river for 20 years, then moved to the Nelson ranch at Norway for seven years, after which they bought a small place in west Myrtle Point. Since Mr. Ray's passing in March of this year, Mrs. Ray had lived in Myrtle Point.

Eight children were born to Mr. and Mrs. Ray, six of whom survive. They are Mrs. Edna Kern, of Coquille; Otha C. Ray, of Myrtle Point; Glen W. Ray, of Rockford, Ill.; Mrs. Lula Jarvis, of Myrtle Point; Mrs. Pearl Johnson and Lucy Bernier, of Marshfield. The oldest son was killed in action the last hour of the world war. Mrs. Ray was one of the Gold Star mothers who journeyed to France in 1930. The youngest daughter, Frances, passed away in Seattle in 1934.

Mrs. Ray was a devout Christian and spent all her time doing for others. She had just completed a crocheted rag rug and six aprons for the Children's Farm Home at Corvallis.

Glen, the youngest son, arrived Tuesday and will take place Friday at 1:30 p. m. from the Schroeder chapel in Myrtle Point, with T. M. White in charge of the services. Burial will be in the Norway cemetery.
