#### **OPA Report Of Farmers And Small Primary Distributors**

Farmers, small primary distributors, and persons making rationed foods for sale or transfer are re-mined to make a monthly report to their local War Price & Rationing Board. Farmers and butchers who slaughter livestock (cattle, calves, sheep, lambs, and swine) and sell or transfer all or part of those meats must report. Farmers and other persons who churn cream into butter or produce rationed cheeses from milk or cream for sale or transfer of any of the butter or cheese, must also report.
