

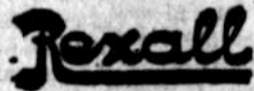

Transfers at North Bend

Transfer of deed was recorded at Coquille showing the purchase by Henry Kern, owner of the North Bend iron works, from the Simpson Estate company of an area 148x120 feet on the waterfront in North Bend where his new foundry now stands. The sale terms were made in August, 1917, the price named being \$7,000. Payment, for which a period of two years was allowed, has recently been completed.

The city of North Bend has also transferred to Kruse & Banks Shipbuilding company its title to the end of Wall street, now included in the yards of the company. The vacation of the street to the industry was arranged almost two years ago. The vacated street is 60 feet wide, extends for 600 feet from the waterfront to the water edge. Property purchased by Kruse & Banks lies on either side of the street vacated.—Coos Bay Times.
