## Council Votes to Issue \$2,500 Warrants to Pay For The Property

Mayor E. E. Johnson called the council together last evening to complete the purchase of the Lamb Grove property for the city. All the councilmen were present and the vote on the ordinance authorizing the issuance of warrants to pay for the property was unanimous. These warrants will bear 6% interest payable semi-annually and may be paid by the city after five years and must be repaid before ten years. The First National Bank will take the entire \$2,500.00.

Mr. Lamb was given thirty days from the date of the transfer to remove the former J. J. Lamb residence and the two barns from the property which is being purchased by the city. He stated that he had a deal on the sale of the house which he expects to move on to Mrs. Fay Jones in a few days.

The only other business transacted was the authorizing of the high commissioner to issue warrants for the new high school building at the west end of the first bridge and a plot at the southwest corner of the school grounds. The next of these matters was very briefly discussed Wednesday evening at the session of the public bill committee.

Last year it was proposed that Coos county should vote a million road bond issue for an extensive plan of road improvement, such as has been approved by an advisory committee appointed at a meeting of representatives of the road districts of the county.

The decision would have been called long ago but for a decision of the Supreme court that would not be finally decided until the fall. The Supreme court has since reversed that decision so that there is now no legal obstacle in the way of such a bond issue by Coos county.

With the road work now in hand and with the amount of both state and county funds will be available, the county is in a position to do a great deal of work.
