Governor Chamberlain's Visit.

As announced last week Gov. Chamberlain arrived at the bay on the Alliance last Wednesday morning, but owing to urgent business at Salem demanding his personal attention, his visit to Coos and Curry counties was much shorter than was expected which was greatly regretted by all.

On his arrival at Marshfield, the Chamberlain Democratic Club took him in charge and gave him a clam bake at Charleston bay in the afternoon and a banquet at the Blanco hotel at night.

The next morning, in company with Mr. Burns, who had gone to meet him, the Governor arrived at this place on the train. The forenoon was spent in looking over our court house and other places of interest and in shaking hands with citizens. In the afternoon the Liberty was chartered and an excursion was taken up the river as far as Fred Schroeder's place. On the return a short stop was made at Fishtrap when an amusing incident occurred—luckily not a more serious one. The Governor in company with Judge Harlocker, J. J. Lamb and John Kronenburg, entered a carriage for the purpose of taking a drive over the Fishtrap country, and had hardly made a start when one wheel "Went to pieces all at once" like the famous "one-hoss shay." All rejoiced that no one was injured, but many were the regrets expressed that no one in the company had a camera to snap His Excellency as he crawled out of the overturned rig.

While here he was the guest of Dr. Wetmore, who gave a dinner with three or four invited guests and in the evening, after an address in the Masonic Hall to an immense throng, a little smoke was enjoyed by the Governor and a dozen or so others.

From this place Mr. Chamberlain and Mr. Burns went to Myrtle Point the next day when an address was made from the veranda of the Myrtle Point hotel. At one o'clock they took a private conveyance for Langlois to be present at the W. O. W. picnic there, which was the Governor's objective point. After an address there at ten o'clock Saturday morning, another at Bandon at 8 in the evening, attendance on the Masonic lodge, a ride to this place Sunday morning on the Dispatch, where he was met by a special train from Marshfield, an address to the Marshfield people in the opera house that night and a ride on the Red Men's goat, our chief executive bade the people of Coos and Curry, with promises of a speedy return.

To say that he made many friends while here, is putting it mildly, but making friends seems to be one of his peculiar characteristics, if one may judge from the vote he has so frequently received at the hands of all parties, regardless of politics.

Coos Bay Will Have Railway

Official announcement was made yesterday afternoon from the office of General Manager O'Brien that the Southern Pacific would build branch from Drain, Douglas County along the course of Elk Creek and the Umpqua River to the coast at Gardiner, thence south along the coast to Marshfield, opening the interior of Coos County to development and commences as soon as the final surveys and right of way work can be completed. The route has been decided upon. The distance is 81 miles. The estimated cost for a standard gauge line of first-class construction is \$3,500,000.

Coos county is one of the rich divisions of Western Oregon, comparatively slightly developed because of lack of transportation facilities, and has heretofore been obliged to trade almost entirely with San Francisco.

A survey has been made by the Southern Pacific Company of a line from Drain, 165 miles south of Portland, to Marshfield, on Coos Bay, a satisfactory route has been found and the line is now being definitely located. The announcement was at the offices of the Southern Pacific Company yesterday that as soon as the line was definitely located and right of way obtained, the work of constructing this line would begin. General Manager O'Brien departed last night for Southern Oregon.

This is one of the most important undertakings in the Northwest for several years, as the new line means the opening up of a vast country between the present line of the Southern Pacific and the ocean, the resources of which are enormous. The road will be about 31 miles in and will closely follow the waters of Elk Creek and the Umpqua River toward Gardiner, there south along the Coast to Marshfield. It will have the distinction of being the first line to cross the Coast Range Mountains in Oregon, as well as the first one to penetrate the heart of one of the greatest timber belts in the world.

The opening of the new section will directly benefit, in a large way, the trade of Portland. It will overcome the present isolation of the extensive Coos Bay county, so long accessible by water only, and the trade, now in its infancy, will grow proportionately with the increase of transportation facilities.

Aside from the lumber industry, which has already reached vast proportions, notwithstanding its only outlet by water, coal is mined in large quantities. Other products are shipped, such as apples and potatoes, while livestock and fish from the bulk of the present outward tonnage. The dairy business tributary to Coos Bay is proportionately greater than any other on the Pacific Coast. Canned salmon will also form a part of the shipments to come out by rail, and the improved transportation facilities will, on doubt, encourage the establishment of other manufacturing plants.

Heretofore, nearly all of the dairy products, and vegetables as well as shipments of livestock from the Coos Bay country, have gone directly to San Francisco. Under the new conditions, it is reasonable to expect that Portland should receive the larger share of this traffic. Coos Bay rivals the famous dairying sections of the Tillamook and Nestucca country, but is much more extensive area. The standing timber along the line of and adjacent to the proposed railway, will now find a ready outlet to markets long denied, owing to lack of adequate transportation facilities.
