Mrs. Captain Magee immediatly telephoned to her husband, captain of the tug Columbia, which was lying at North Bend, and the tug started to the relief of the vessel. In the meantime, the Life Saving crew had started for the bar and ran out alongside of the unfortunate steamer, but seeing that there was no immediate danger, they put back


