## Money is on Hands for Jotty Work

Colonel S. W. Roesler was officially notified this morning of the passage of the river and harbor bill by Congress, and of the sums set aside for improvement work in this district. He was also instructed to forward to the Chief Engineer a list of the several projects under way in the district, and to report on what work as to be done. The request of the department is being attended to today, and in a week or so the extension of the Government jetty at the mouth of the Columbia River will be in full progress.

As soon as the list is received in Washington, Colonel Roesler says it is customary for the department to send a telegraph message to each of the engineers in charge, empowering them to go ahead. Rock and other material for extending the jetty will be secured in the open market until arrangements can be completed to get them from the lowest bidders by advertising. Considerable lumber is already on the grounds, and it is probable that on the start rock will be secured at Fisher's quarry.

Colonel Roesler was also notified that the new dredge for operation in Oregon and Washington waters, for which an appropriation of \$120,000 was made, will be build under the direction of the Portland office, instead of being left to the Seattle force of United States Engineers. In the bill nothing was said about this matter, and there was a conflict in opinions. The Chief of Engineers decided in favor of Portland.

The new dredge will be operated at Coos and Tillamook Bays and at the several ports of Washington, deepening the channels and making other improvements. The building of the craft will be let to the lowest bidder. Seattle will have a chance to get the work, but her contractors will have to apply for the business through the Portland office.

Before long the work of building several drill scows and a steamer for use as a tender on the Upper Columbia River will be started. They will be used for making improvements to the river between Celilo and the Snake River. When Spring opens in good shape operations all over the district in the river and harbor line will be on full blast.—Telegram.

## Auto Mail Cars.

After experimenting for more than a year the Postoffice Department has decided to use especially constructed automobiles, equipped much the same as railway mail cars, as a means of collecting mail from post boxes in Washington, thus doing away with the horse and cart service so long used. The new method will save time in the handling of mail, for while the car speeds along, operated by a chauffeur, the clerk inside the car will assort the letters and have them all in readiness for the stamping machine when the postoffice is reached. Under the present system the mail is dumped into a sack and is assorted in the postoffice.

Up to the present time this scheme, in a modified form has proven a success in Baltimore and Milwaukee but Washington is the first city to secure automobiles constructed especially for the purpose. They are about the size of an ordinary street car, contain pouches and sorting boxes along each side of the interior and provide ample room for the hurried work of the clerk.

After Washington is properly equipped, the cities of Detroit and Louisville have been selected, as places where these machines shall be installed as a part of the mail service and gradually, it is said, this modern means of mail collecting will not only be established in all cities and in towns of large size but in the rural service as well. It is believed by the officials that one machine can be made to cover several routes that are now taken care of by a horse and wagon for each route. Unless all signs fail, the auto-car is slated as a permanent fixture in Uncle Sam's mail service.

## Divorec and the Child

Professor Felix Adler offers an incontrovertible argument in favor of the permanency of marriage in the Woman's Home Companion for March. He holds that a permanent home is necessary to insure the best development of the child, because it needs both parents in order that it may grow in the best possible manner, physically, mentally and morally. The gist of the matter is that those who have united to give life to a human being should stay united to cherish and develop that life. Dr Adler adds:

"The divorce movement of late years had an alarming growth, not only in the United States, but in almost every civilized country of the world. The causes which have contributed to this growth are numerous and complex, but undoubtedly one of the most active has been the spread of Democracy, or rather of that individualistic view of life of which Democracy is the political expression. To-day, as never, as before, the individual is asserting his claims to the full enjoyment of life's opportunities; and while this movement has been productive of lasting benefits, it has also been coupled with a wide-spread disposition to resist the pressure of social obligations which interfere, however necessarily, with individual liberty or happiness. The conjugal tie and the duties of parenthood springing from it is all human relations the one in respect to which the weight of social obligation is most directly felt; and it is at this point, therefore, that mutinous individualism has put forth its most determined struggles. The conjugal relation has a twofold aspect: It is a relation between the partners in marriage themselves, and a relation to offspring. A characteristic feature of militant individualism is that in the discussion of marriage, the former of these aspects is preferentially emphasized, while the latter is more or less thrown into the shade. The right of married persons to obtain relief from a tie which is no longer pleasing, is considered from the point of view of their own happiness; while the rights of the child are as affected by divorce are treated with the most superficial attention.

"There is one other point to which, in conclusion, reference may be made: The attempt to amend the laws on the subject of divorce is helpful, inasmuch as it leads all those who are engaged in this enterprise to realize the ultimate inadequateness of any laws, however stringent, however wise, and to search for a deeper remedy than any which legislation can supply."

## Four Land-fraud Men are Sentenced.

Omaha, March 18.—Four men convicted here last December in the sensational Government land fraud case were sentenced today by Judge Munger in the United States court, as follows:

Bartlett Richards and William G. Comstock, to pay a fine of \$1500 each and to serve a year in the county jail.

Charles O. Jameson and Aquill Triplett to pay a fine of \$500 each and serve eight months in the county jail. All the defendants filed motions of appeal which will be argued later.

These men were indicted by the Federal grand jury for conspiracy to defraud the Government out of the use, possession and title to upward of 200,000 acres in Northwestern Nebraska. Their trial was begun last November, and 13 witnesses were examined.

## SUMMONS.

IN THE CIRCUIT COURT OF THE STATE OF OREGON, IN AND FOR THE COUNTY OF COOS:

A. E. Seaman, Plaintiff, vs. Henry Fletcher, Minnie Fletcher, and John Doe, Defendants. [Suit in Equity to Quiet Title to Real Property.]

To Henry Fletcher, Minnie Fletcher and John Doe, the above-named defendants: You and each of you, are hereby notified that you are required to appear and answer the complaint filed against you in the above entitled court and cause, in which A. E. Seaman is plaintiff and you, the said Henry Fletcher, Minnie Fletcher and John Doe are defendants, within six weeks from the date of the first publication of this summons, to-wit: Within six weeks from the 18th day of March, 1907, and if you fail so to appear and answer on or before the 24th day of April, 1907, that said being the last day of the time prescribed in the order of publication, the said plaintiff will apply to the court for the relief demanded in the complaint in this suit, a succinct statement of which relief is as follows:
