THE NEW BANDON MILL Where Logs are "Chawed" Up Into Lumbe While You Wait.

Reader, did you ever go through a big sawmill, and watch those huge bandsaws chew up logs at about the rate of a mile a minute? No! Well, then, you have missed the time of your life, and you want get busy at once.

Next in importance to the Smith plant at Marshfield is the big Cody sawmill at Bandon recently completed at an enormous expense, and now in full operation. This plant is one of the most modern constructed in all its details that the writer has ever looked over, and he has seen a few in his time. A levitation of a building with a floor space area equal to a city block, presents an imposing appearance to the beholder at a first glance, which is immeasurably enhanced when the activity within is investigated and disclosed.

Four powerful boilers, capable of generating an immense volume of steam at a pressure of 200 pounds to the square inch backed up by modern engines of large proportions supply the motive power that run this immense plant. Four huge bandsaws of the finest make and pattern, put their teeth into the logs, and in less time than it takes to record it, the huge monarchs of the forest are turned into lumber at the rate of 100,000 feet per day, ready for shipment. By running a night shift this output can be largely increased, and all the facilities are at hand and ready for just such an emergency, when it arises.

Some sixty hands are employed in the plant, skilled and unskilled labor, ranging per diem from \$2 to \$6, involving a weekly payroll of wonderful proportions. In addition to this force forty men are at work in the woods, felling trees and cutting them into lengths and getting them to the mill by rail and the river. This adds another large sum to the payroll, all of which is of material benefit to Bandon.

The output of the mill, over what is taken up by home demand is largely shipped to the Orient, where it is in great demand on account of the excellence of its character. The mill management has enough valuable timberlands of its own to last them a quarter of a century at least and will acquire more from time to time, as opportunity presents. Taken in all its entirety, the mill is one of the best in the world, a lasting credit to its projectors and the community in which it is located. As a commercial commodity, it is an invaluable adjunct to the growth and prosperity of Coos county, and a lasting monument to the men who erected it.

A Beautiful Gift

Our genial friend, Judge E. G. D. Holden, is wearing an unusually happy smile round with him these days, the inciting cause of which is that he has recently received from the Grand Lodge, of Michigan I. O. O. F. a magnificent Past Grand Master's jewel, of that order.

It bears the following legend: "E. G. D. Holden, P. G. M. 1880, Michigan," on its front, with this inscription on the back, of a two and one-half inch gold and silver star: "Presented by order of Michigan Grand Lodge, 1907." The jewel bears several emblems of the order: The All Seeing Eye; The Three Lukes; The Heart in Hand; and the Past Grand Master's distinctive emblem, the Gold and Silver star, the entire jewel, being neatly lodged in a silk lined, morocco case 3 x 6 inches in size, and about one inch deep, and all together jewel and case, the richest, and neatest thing of the kind we have ever seen. No wonder the Judge wears a smile. Most of us would, with such a present as that.

The Grand Secretary of the Order in Michigan, in transmitting the jewel says: "Though you are far away, this jewel, will serve as a reminder, that you are not forgotten by the Old Fellows of Michigan. It was long ago, well earned."

At the time our friend was Grand Master, in 1880, there were 303 Lodges in Michigan, having a membership of 13,341. Twenty seven years later, at the time the jewel was ordered, there were 519 Lodges, and 47,413 members, which surely shows, a generous growth of the order, in that state, being more than three and one half to one, from the day of Judge Holden's Grand Mastership.

A new generation has arisen since that day, but they can not forget one who was long identified with the work of Odd Fellowship, in that state.

Numerically, statistics show, that the I. O. O. F. is the largest secret order in the world, though it is only 89 years old this month, and that it dispenses the most hard cash, for the benefit of suffering humanity. One of the tenets of its creed is this: "We command you to visit the sick; relieve the distressed, bury the dead, and educate the orphan." And they do it, fulfilling God's law as well.

Eugene, Oregon, April 7, 1908. An attempt is being made by the enemies of the University of Oregon to create prejudice against the appropriation bill through misrepresentation. They claim that the University hires a football coach at 1500 for a little more than two month "instruction". As a matter of fact, the University has nothing to do with the hiring of a coach, other than to see that he is the right kind of man. Neither have the students ever paid 1500 for a coach, and further, the coach's salary is paid entirely from the gate receipts of such games as the ones with the Oregon Agricultural College and Multnomah. They say that the increase in the appropriation is 300 per cent when they know that the university has received 78, 500 for the past two years, and the increase can only be 56 per cent. Even if the one item of 47,500 of the old appropriation bill were taken, the increase would be only a little over half of what they say, also that the University has shown bad faith in pushing this bill by going to the courts on technicalities. As a matter of record, the enemies of the University were the first to appeal to the courts, when the Secretary of State refused to file their petitions, and later carried the case to the Supreme Court. The friends of the University have appealed to the courts only once, and then when the title was manifestly unjust and misleading. Those are but examples of the misrepresentation used by the opposition throughout their arguments.

Charter Amendments.

EDITOR HERALD: Since the publishing of the charter amendments authorized by the city council of Coquille, Oregon, I would most respectfully submit to your readers through the medium of your estimable publication my views on the proposed amendments. First. The amendments as offered are plainly unconstitutional. The Initiative and Referendum law as it stands covers the ground thoroughly, and those amendments to become legal material for the consideration of the voters of your city, should have been initiated in proper manner under the provisions of the law referred to.

Second. While there are clauses contained in the amendments that are absolutely necessary to safeguard the acts of a municipality, yet as a whole the instrument is weak and inadequate for the needs of a growing city like Coquille. For instance, I cite you to section 6; that section 2 of article 6 of said section 2, grants the common council the power to open, grade and improve any and all streets, side and cross walks within the city limits. Section 2 further provides that the costs of such improvement shall be paid by the land or lot owners on or abutting on such street to be improved. Section 2 also provides for the surveying, platting, etc., and the city must pay therefor.

Section 7. That Sec. 3 of article VIII of said act be amended. Section 3 provides that the common council shall have power to go ahead and make such improvements as may be found necessary but the proviso contained in the section kills the power of the council to do anything.

And so all the way down the line, investing the common council with the power to act and defeating any action through the remonstrance of two-thirds of the property owners on the street, side or cross walk or sewer to be constructed or improved. If there is anything right or just in the idea of forcing the property owner to pay for all street improvement, then I have no true conception of the work of justice, and right here I want to ask a question: What is the tax for anyway; why do people pay taxes if not to establish streets, side and cross walks and sewer systems. The amendments are a very cunningly devised plan to defeat the growth of the city and enable its officers to squander the city's money by ordering surveys and improvements and allowing the property owners to defeat its action. The people should, in the estimation of your observer, vote these amendments down and out. A new out and out charter based upon a more popular idea should be presented by referendum petition.

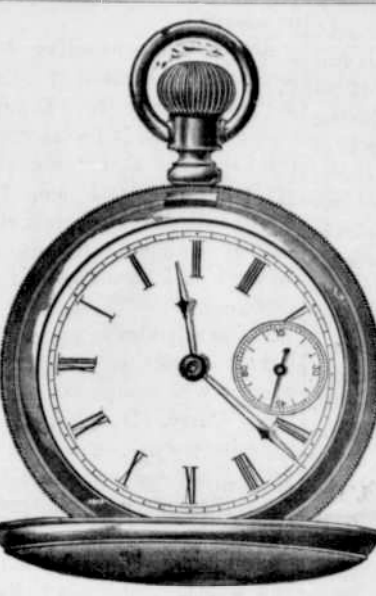
