He is discouraged-his spirit broken by the refusal of Roosevelt and Taft to enlist their aid for his reelectic :

There will be some important legislation of a general nature to consider at this session, much of which will be outlined and recommended in the Governor's message. Among the measures that should be passed is the one to increase the bounty on panthers, coyotes, wildcats, and other destructive animals so numerous and multiplying in the State at present. Some of these varmints are as destructive of deer as they are of sheep and other stock. There should also be better protection for elk.




