Attends Apple Show.

Coos county was represented at the Spokane Apple Show in the person of George W. Beale, our well known orchardist and progressive farmer. Mr Beale returned on the Alliance this week and declares the show to have been a grand success. He gained much information from his observations and inquiries as to the growing of Oregon's big red apple.

Mr. Beale was frank in admitting that in this section, which is especially adapted for apple growing and where the fruit pest is less observed than in any section of the world, is behind the times in this most important branch of horticulture. "In the north the fruit grower has made a science of his business," said Mr. Beale, "and on this particular point we are shy. With our facilities, and a territory famed for its being free from pests, we should do better. We have gained a standard in the dairying industry that we should try to emulate in our fruit growing."

Mr. Beale will urge his neighbors to engage more extensively in fruit-growing and from a scientific standpoint. He claimed that the profits derived from apple growing are larger than from any other line the farmer has an opportunity to traffic in.—Sun.

Oregon Apples Win.

Spokane, Nov. 25.—The sweepstakes prize of \$1,000 for the finest exhibit of a full carload of apples at the National apple show was awarded this afternoon to Tronson and Guthrie of Eagle point, Ore., for a display of Spitzenbergs.

The award carries with it a gold medal banner and the title of "Apple King of the World."

The prize for the "largest perfect apples" was awarded to Lorr and Ball of Methow, Wash., for a Wolf River apple weighing 25 ounces and 17 5/8 inches in circumference.

A "Spokane Beauty" apple weighing 41 ounces and 18 5/8 inches in circumference was expected to be the winner but proved to have a blemish.

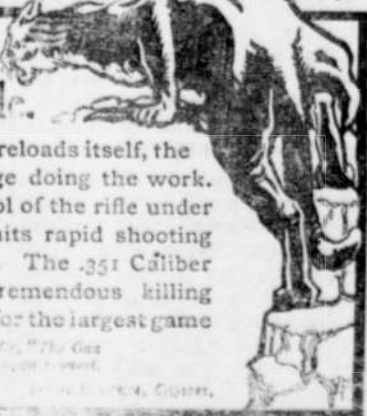
