St. Bidwell Re-established.

San Francisco, March 23.—The secretary of war has decided not to abandon Fort Bidwell, California. This post was decided upon some time ago as one of no value or strategic importance, and its abandonment was ordered. It is not known what causes contributed to this reversal of decision, but this morning General Gibbon issued an order directing that Troop C, Fourth Cavalry, be relieved from duty in the department of the Columbia at Walla Walla, and take their station at Fort Bidwell. The troops will march from Fort Walla Walla.

Rogue River Reservation Lands.

Washington dispatch, March 23d.] It was generally believed by some people in Oregon that a treaty was made with the Rogue river Indians in 1851 for a cession of a portion of their reservation lying south of the Rogue river. It was ascertained the exact status of this treaty and its provisions that Senator Mitchell introduced and had passed a resolution calling upon the secretary of the interior for a copy of the treaty. This agreement was sent to the senate, but it was found that it contains no provision for a cession of lands by the Indians. These Indians agreed with Governor Gaines to stop fighting and to put themselves under the guardianship of the government. This agreement, made forty years ago, is witnessed by a number of early settlers of Oregon who have been identified with the development of the state. Among those who signed it were: C. M. Walker, H. H. Spaulding, Secretary Porter, Matthew Hall, William H. Rector, James Pay, L. W. Pent Huntington and P. P. Bailey.

A New Enterprise by Bro. Billings.

When the woman-evangelist undertook to particularly "dress down" the people of this town for their indifference to her shriek out, "Why is it that there are so many saloons, so many gambling dens, so many houses of ill-fame in this city?" She would generally answer her own conundrum by shouting that the town was rotten to the core with infidelity, and that the first thing that the evangelist done in Ashland was to call on the two high-toned and elegant looking females known as "Missouri seamstress" and "The Water street seamstress." Anybody doubts the statement that Billings does rent the house to the ill-reputed woman known as "Feathers" the receipt of this paper will show them the receipt, signed and written out in Billings' own handwriting, dated March 2, 1891, which is in the possession of a citizen of this town.

Mrs. Molloy, the Evangelist.

Mrs. Emma Molloy-Barrett, the evangelist, was taken ill Friday. The party was supposed to have perished, have not all returned. The horse was found in a potato. The saddle had been taken off and the horse's head had been broken overcoat was found near the horse with letters addressed to Colver. There is no doubt of his fate, although no body was found. It is supposed that by trying the horse's head up out of the water Colver started for help, but being crippled by a leg which had been broken some time before, became exhausted and perished.

The Perishing of Uncle Sam Colver.

The Brocken's advices up to noon today was that the search party was still out and that his carcass had been fished out of a body of water twenty feet deep at a point eight miles north of Linkville toward Polican bay. The party were expecting to be able to find his body within a few days now, either in Klamath lake or one of the bays of that stream. Mr. Colver had his raft on horse back before the snow storm and the neighbors thought he had arrived safely in the spring creek. He was wearing crutches at the time, having been covered from the effects of a broken leg. He was undoubtedly trying to get out of the snow which had been broken up and fell through the snow into the pond where his carcass was found.

Lewis, the Methodist minister and a handful of others who were instrumental in bringing her here, pretend to think that an evangelist is at all right, at the same time refusing to give the public one scintilla of information or logical proof of her belief. For their benefit we publish some more information in this issue. If they are not well satisfied that Mrs. Molloy is not at least 50 years of age, the most immoral person that ever stepped into this community, we will supply them with still further convincing proofs. But we fear that not a man came through Rogue river valley in June, 1852, and found Mr. Colver on the plain where "Phoenix" now is. He was then a well-to-do, kind hearted, public spirited man. At the first republican meeting I remember, held at Jacksonville, he was one of the leaders, and he was always a leader in what he undertook.

Catching Suckers.

Linkville Star.] D. W. Anderson, at Lost river gap, sends a dog fishing for suckers, and the animal does very well.
