The Cattle Market.

Says the R. R. Journal: Beef cattle seem to be in demand throughout the country. Those shipped to Chicago from Lovelocks by Sibbald & Savage netted over \$45 per head, and there is a market for all that may be shipped. Bees are scarce in Washington, too, and George Wright is here from Puget sound buying up all the fat cattle that are for sale. Mr. Wright bought eight carloads of G. W. Maps and ten carloads of F. J. Frey for shipment to Puget sound, and he went to Lovelocks to buy all the fat cattle the Captain Marzen has for sale.

It is a relief to cattlemen to know that they are no longer dependent upon the San Francisco market, and that they can ship their beaver north to Portland or Puget sound or east to Omaha and Chicago and get better prices for them than in San Francisco. Mr. Wright is paying 6 1/2 for good cattle delivered at Reno.
