The supreme court has rendered a decision that will be generally regarded with as much favor as that of Judge Boise, which it reverses, was with disfavor, except by a few small men. They hold that the law prohibiting the deposit of sawdust in streams is constitutional and therefore valid. This may be some little inconvenience to the lumber manufacturers, which is to be regretted, but it will save the fish in many of our streams from destruction, which is of far more importance.
