They were held in jail for some time, but before being taken to Grants Pass, they confessed and were bonded over, but before being taken to Portland, broke out of the jail and were never heard of again. The following from the Albany Democrat shows that their sins have found them out after all.

Last December Frank Coon was indicted at The Dalles for uttering counterfeit coin. Coon's whereabouts were not known for several months until recently when it was learned that he was working on the Oregonian railroad in this county. A warrant was issued for his arrest when the sheriff and Deputy D. S. Smith went to Lawson, where they found and arrested Coon, among nearly two hundred other men, Deputy Sheriff Smith, of The Dalles, arrived in Albany last night and took Coon to The Dalles today.
