The Great Northern Route.

Redding Free Press.

A Post reporter has interviewed an officer of the Great Northern Railway, from which interview we glean the following information which will interest people in this northern end of the State:

No less than four surveys have been made through Northwestern California with a view to what route will be the best to reach San Francisco from Boise City. But two of the routes have been considered, and by both of them it is proposed to make use of the Donahue system.
