Grants Pass-Eureka Railroad.
Eureka, Nov. 6.—The people of Eureka now have before them a proposition from T. S. Hullock and his associates, who built the Sierra Railroad to the mines from Oakdale, to build a railroad about 100 miles long from Eureka to Grants Pass, in Josephine county. Or. Eighty miles of this road would pass through the heart of the timbered forest from north to south, and the whole road would open an empire vast richness for settlement.
Hullock and his associates ask for certain rights of way and terminal grounds, also that the people furnish purchasers for \$75,000 of their first mortgage bonds, limited to \$20,000 per mile and payable in installments of \$75,000 on completion of each ten miles of the road until the amount is paid. The business is very anxious to give the proposed road an assistance in their power. A large number of the people of Eureka are anxious to contribute liberally to a fund to be given to the first purchasers of the \$75,000 bonds, if such purchasers can be found.
