W. H. Staats and Fred Staats are both down with the grippe, and now looks like a hospital in Mr. Staats' home.

The old postoffice building was moved across the street, this week to a lot near the new store, and is now occupied by White & Hill's Meat Market.

Sylvester Staats, son of W. H. Staats, has been suffering from a very severe attack of the grippe, he is still confined to his bed but is improving slowly.

The residents of our little town seem to have caught the spring fever and have improved the appearance of the place very much by cleaning their yards and removing unsightly fences, let the good work go on.

Owing to the loss of the Crooked River bridge, no paper mail arrives at this place last Monday, the mail carrier was obliged to travel on horse-back as far as Powell Buttes, where he procured a team and made his trip on schedule time.

Reed & Steidl, have received a load of machinery for their sawmill and expect more in a few days. They will then begin placing the machinery in position, and expect to be sawing lumber for the market by the 15th, of the month.

The young ladies expected to return to Prineville on their friends could not cross Crooked river to come after them, therefore the young ladies returned to their farm, after a pleasant call at the Echo office.

John Steidl, Dick Vanlevert, Frank Hodson, Avery Scoggin and Henry Tweet, tried water navigation with disastrous results last Monday they built a flat-boat in which they might cross Crooked river where the bridge had gone out. They placed their buggy, a trunk and various other parcels on the boat, then Steidl and Scoggin got on board and pushed out into the stream where the current caught the boat and stood it on end in a moment, spilling men, buggy and all into the river, after quite an effort the men got ashore. The next day they fished out the buggy and trunk, but a number of things were lost among which, was an overcoat and a new suit of clothing belonging to Mr. Hodson, and Mr. Steidl's overcoat, the contents of the trunk, which belonged to Mr. Tweet, was almost ruined by the muddy water.
