More Reserves to be Created.

The Dalles, Or., July 31 .-(Special.) - A department order was received today by the local land office in this city to withdraw from settlement or appropriation townships 18, 19 and 20 in ranges 10 and 11, townships 19 and 20 in ranges 12, 13, 14 and 15, and township 20 in range 16, all south and east of the Willamette meridian.

This is one of the largest withdrawals ever made in this district and covers an area of over 300,000 acres of land, the most of which lies within the timber belt of Crook county. The withdrawn townships extend from the boundaries of the Cascade forest reserve east along the southern line of The Dalles land district 42 miles, including the postoffice of Lava and some tracts covered by state selections under the Carey act.

About one-third of the land withdrawn is covered by timber and stone filings.-Oregonian.

Fabulous Wages Were Paid.

In rumaging about his office this week, County Clerk Sleight unearthed some official records that contain some interesting statistics with reference to this county in the early 50's. They consist of some social statistics compiled by Joseph T. Meek, who was then territorial marshal of Clackamas county, in June, 1850. In that year the assessable value of property in this county was \$1,020,844, classified as follows: Real estate, \$836,650. personal, \$123.694. The schedule of wages paid at that time was remarkable. The average monthly wages to farm hands, including board, was \$80; the average wages paid day laborers with board was \$4, without board, \$6; average daily wages for carpenter, \$12; board per week for laboring men cost \$8. There were then two weekly papers in the county, viz: Oregon Spectator, Territorial; and Western Star, Multnomah. An idea of the value and profit in the lumber business at that early date may be gathered from the statis tics which show that Benjamin Simpson from 400 logs for which he paid \$3 each, manufactured 100,000 feet of lumber which had a U. S. Land Office, Lakeview, Oregon, salable value of \$75 per M .- Ore-
