The recent wet weather and very muddy streets convince us that Newberg needs at least one or two streets running parallel with First and Main streets, so that the travel might be more diversified, and these two main thoroughfares might in a degree be protected from the almost incessant travel. In this way all the streets would be better, and there need not be a muddy mess of mud and water on the streets the past few weeks.

On January 20, the Southern Pacific will increase freight rates between Portland and this place about two-thirds, making first-class freight twenty cents per hundred instead of twelve as at present. This is little short of robbery, and the people here should see to it that some better facilities are afforded for storage at the river, and have their goods transported by steamer. We learn that this move is being considered, and if it is carried out it will relieve our merchants and shippers of a great burden.

The musical entertainment at the Friends' church Tuesday evening, was well attended and well received. Considering that most of the performers were inexperienced, and that a number had really little time for drill, the entertainment was very good. Some of the exercises were really fine. STATE HORTICULTURAL SOCIETY.

PORTLAND, Jan. 13.—The seventh annual meeting of the Oregon State Horticultural Society met at the council chamber in this city yesterday, with Dr. J. W. Cardwell in the chair and E. W. Allen acting as secretary in the absence of Prof. E. R. Lake, whose duties in connection with his position as professor in the new agricultural college in Washington, prevented his attendance. In the loss of Prof. Lake the members of the society realize that one of the most valuable members is lost, and that his place as secretary will be hard to fill.

Newberg is well represented, the following being in attendance: G. L. Stabler, G. W. Mitchell, E. C. Armstrong, Cyrus Hoskins, J. H. Rees, Dr. A. Mills, Seth Mills, Wm. Allen, wife and daughter, J. H. Bowerman and E. H. Skinner, making a larger delegation than comes from any other place except Portland.

The association now has a larger membership than any other horticultural society on the coast. Much interest is manifested in the meeting, there always being plenty of speakers ready to discuss all papers that are read. I only regret that there are not more of our Newberg fruit men present to hear the discussions which always bring out many points of interest to the man who really wants to be proficient in the business of fruit raising.

It is a sad fact however that now as in the past, the producing classes are too much inclined to hole themselves up at home and "go it alone," while business men of almost all professions have their meetings to devise means for bettering their condition.

Seth Winquest, a young man from Russellville, read a paper on "Dishonest Seelamen," roundly scoring a Portland firm for selling him California peach pits claiming that they had received them direct from Virginia. Secretary Allen said that while he deplored the fact that the firm spoken of had misrepresented their pits, he thought it really fortunate for the buyer, as the state board was doing all in its power to prevent the introduction of eastern pits, as well as peach trees, fearing the introduction of the "yellows," a disease that has proven fatal to peach growing in the eastern states. The next paper was by A. H. Dodd, of Falls City, on "Cultivating and Manning." As evidence that one cannot always tell what there is in a man by his outward appearance, we will say that when Mr. Dodd made his appearance our first thought was that we would be bored for half an hour with a poorly-written dry paper, not judging from the man's clothes at all, but from his general make up. The fact is that he read one of the most carefully written papers we have yet heard, making many happy hits. His fatal mistake however, as a beginner in orarding, is his conclusion that it will do to seed a young orchard down to timothy, and depend on digging about the trees for cultivation. Experience will soon show him his error in this particular, and we hope none of our fruit growers will follow his example.

The president's annual address, which was read last night, was a review of the work of the past year, which he said had been the most satisfactory of any year's work of the society. The July meeting, held at Newberg, he referred to as being especially interesting and satisfactory.

Our Mr. E. H. Skinner, in a paper entitled "What is the Future Prospect for the Fruit Industry of Oregon?" made some very pertinent remarks, full of encouragement for fruit growers, and ridiculing the idea that the fruit business is going to be overdone in Oregon. "Present Opportunity of Northwest Fruit Growers," by C. A. Tonneson, of Tacoma, and "A Few Thoughts for the Horticulturist," by Rev. A. Rogers, of Forest Grove, the latter being especially interesting, closed yesterday's work.
