Will Hofer win that hat?

The Oakland Observer is not at all, its accounts and subscription list having been turned over to the Roseburg Plaindealer.

An exchange says: "A saloon can no more run without using up the boys than a flouring mill can run without wheat, or a saw mill without logs. The important question is; whose boys, yours or mine?"

Some of the crack-brained advocates of government saloons, ought to father a scheme to get the government to stand behind the Louisiana lottery. One is just as sensible as the other, and not less dangerous.

The Salem City Council passed an ordinance distasteful to the flouring mill company there, and that concern is going to cut off its nose by refusing to run. Corporations are very much like individuals sometimes.

As an evidence that larceny is considered a greater crime in Oregon than the killing of a fellow being, note the following from the report of Sheriff Birdsley, of Jackson county: Four men were given two years each for larceny, while one man found guilty of manslaughter was given only one year.

The people will hereafter have no occasion to make excuses for the typographical appearance of the Oregonian. It came out Saturday in its new look. Every department has been completely overhauled and some new features added. Although it does itself proud as the biggest daily in the whole northwest.

How humiliating would be the spectacle of congress considering for a moment the question of licensing lotteries, presumably on the ground that they cannot be prohibited. This is however the argument advanced by the liquor licence advocates, and only tends to show a lack of proper respect for governmental power.

Astoria people are complaining because they were foolish enough to pay a dollar apiece to see John L. Sullivan, and when he appeared on the stage he was drunk. What else could they have expected? Anybody who is fool enough to pay a dollar to see this Boston brute, ought to be privileged to see him in his natural state, as the Astorians did.

Oregon is not the only part of Uncle Sam's domain that is being laboring with unusually bad roads during the winter. The Indiana Farmer says that the mud blockade has put a stop to business in portions of Illinois and Iowa to such an extent as to bankrupt the merchants who laid in large supplies of goods for the holiday season and were unable to dispose of them.

The talk that the mortgage tax and usury law tend to keep money out of the state, applies only to those states where an "investment" means a speculation off of the misfortunes of the people. It does not apply to Oregon. There are any number of opportunities for profitable investment to be met with in this state aside from euthroath mortgage and loan investments, and if you will notice real close you will see that this fact is receiving due recognition at the hands of capitalists.

At the State Horticultural meeting held in Portland last week the necessity for prompt action in the matter of raising a fund for making a creditable display of horticultural products at the Columbian Exposition was freely discussed, and a committee of five was appointed to look after soliciting for subscriptions. We are unable to give the names of the committee in full, but Cyrus Hoskins of this place, is one of them. Subscribers to the amount of several hundred dollars were taken in the meeting, as a starter, Mr. Hoskins and a few others subscribing \$100 each. While it is to be regretted that the moss-back legislature that met at Salem last winter failed to make any appropriation for a display at the World's Fair, it is no time to fold our hands and lose valuable time bawling that fact; while California on one side and Washington on the other are each drilling for a mammoth display of their products.

While as Oregonians we may be like Captain Hanks "hard workin'" and "slow savin,'" we don't want to be considered the tail end of the whole country. In our fruit products especially we can make a display that will open the eyes of the world, if a liberal amount of money is guaranteed immediately. It is only a few months now until some kinds of fruits must be preserved if a proper collection is made, and there is no time to lose. There seems to be no way to raise the money except by private subscriptions and we hope to see the people give the committee substantial encouragement. Let the papers throughout the valley take the subject up and give the movement all possible momentum and assist in raising funds for a respectable showing of Oregon's horticultural products. We hope to see the newspapers of Yamhill county especially make favorable mention of the scheme.

Nearly all our exchanges are devoting some space to the road question. In this we see a hopeful sign for we notice that parties interested in good roads are getting interested enough to discuss the question through the papers. A radical change in any thing requires agitation, and we look to see some good come of all the talk on the road improvement question. Let 'er come.

Some Roseburg lads, who had disturbed the peace of the city by observing that car-splitting, barbaric custom known as a "shivaree," were arrested and fined by the city recorder. That they got what they deserved, most people will agree, for so great has this nuisance become that it will take heroic treatment to effect a cure. Let the men and boys about Newberg take warning by this, and if they have no regard for the feelings of others let them regard the interests of their pocketbooks to the extent that they will not participate in such orgies.

The Humboldt Chamber of Commerce has issued a petition to Congress asking for a favorable consideration of the question of opening all the available harbors on the Pacific coast. This would no doubt be a good thing, but our observations lead us to think that in the matter of river and harbor improvements those who ask least usually get most. The better plan, we think, is to settle on one thing at a time and work for its accomplishment, and having gained it take up something else. The world was not made in a day, and people, even senators and congressmen, are prone to look upon these big demands as some sort of jobbery the appearance of which it is best always to avoid.

Following are the recommendations that the state board of equalization will make to the state legislature asking for their immediate action:

First—The assessment of all property as to its ownership on a day and hour certain as 6 a. m., March 1st, annually. Second—That no deductions for indebtedness be allowed, except when there is corresponding taxable credit. The enactment in all cases of a sufficient penalty for refusal to properly verify or list property. To compel banks to make lists of depositors, and also a list of their own notes held by them against their debtors. To abolish all forms of indebtedness and to also repeal the mortgage tax law. To assess corporations on their gross earnings. To compel assessors to assess all property at its money value and to provide a penalty for such failure.

RELATIVE TO THE WORK OF THE STATE BOARD OF HORTICULTURE, the Oregonian says: "It is evident that if the board is to accomplish the work it is organized to do, it must have a larger appropriation, or those specially interested in the fruit industry must come to its relief. More thorough work than was done last season will be necessary the coming season, but as the board did then all its limited means made possible, its work must be supported in some practical way, or else the merry worm and the jocular scale will enjoy life and raise big families undisturbed in hundreds of orchards, from which they will emigrate at their own sweet will. A vigorous fight all over the state is necessary to preserve the fruit industry and enable it to expand to the enormous proportions it is possible for it to attain, and this fight must be continuous and unrelaxing and be carried on in every orchard in the state. Now is the time to prepare for the battle. Indeed, now is the time for actual contest, so far as the prevention of the planting of affected trees is concerned, or the importation of diseased trees and fruit from other states. There is no season when aggressive vigilance can be relaxed with safety."
