SALEM will be in fine trim to ask for
some kind of an appropriation at the
hands of the next legislature. What with
a great ball team in the league and its
"great importance" as a horse town,
there will not be much ready cash left by
fall.

THE Portland Dispatch man had as

SENATORS MITCHELL, of Oregon, Turpie,
of Indiana, Chandler of New Hampshire,
and Palmer, of Illinois, have each intro-
duced a proposition to amend the consti-
tution so that Senators may be elected by
popular vote. Mr. Mitchell says that a
sub-committee of the committee on
Privileges and Elections has agreed to re-
port favorably.

COUNTY SUPERINTENDENT L. H. BAKER
informs us that he will not be a candi-
date for re-election, as he has held that
office for a number of terms and thinks
best to let some one else have it. Mr.
Buchanan, of Anity, and two gentlemen
from Dayton, are said to be candidates for
the office. This is a very important
office and we hope the right man will be
found for the place.

THE subject of beet culture is going to
attract considerable attention among
farmers throughout the state this year.
The bounty on sugars has created a desire
to investigate along this line. Yamhill
ranks among the foremost in the amount
of sugar contained in the specimens
tested so far, and a beet sugar factory
costing half a million is among the possi-
bilities for this county in the near future.

THE Coming Century will come no
more. It is in the hands of a receiver.
If the company had come away with Mrs.
Dunnaway a little sooner it might have
lived till the "robins nest again," or even
longer. Mrs. D. lays all the blame on
the shoulders of the other fellows, and
announces her intention of starting an
other freak soon, informing the reporter
that she has a full half-bushel of accepted
M.S. to draw from.

A STATE Poultry and Pet Stock Associa-
tion is being formed at Salem. A special
show of three days will commence on
March 25th. This is certainly a step in
the right direction. In a country where
eggs and poultry bring such prices as
they do in Oregon, such an interest
should be taken in the business as will
properly qualify the person engaged in it
in every way so that he may succeed well
in his undertaking. A state association
will certainly have a tendency to stimu-
late those who enjoy poultry raising for
pleasure and profit.

THE Telephone Register man need not
rend his clothes and put on sack cloth
and ashes in his great fear of the dark
deeds of the "ring" in connection with
the candidacy of J. L. Hoskins for the
office of county clerk. The Graphic is
not a political paper and has nothing to
answer for politically, and as for Mr. Hos-
kins, he and his friends don't appear to
feel any pressing need for the advice of
the Register at present. If counsel should
be wanted later on, they will not doubt be
willing to pay the Register man all his ad-
vice is worth, and the bill will not be
very heavy either.

TUESDAY'S Oregonian refers to "Lish"
Applegate as "the man who lost his com-
mission as Indian agent at the Klamath
reservation because of his religion." This
was not the reason of his removal at
all, for anybody that knows Applegate,
knows he has no religion. When he
went to Klamath he swore he would take
all the Christ out of the Indians and of
course he soon lost the respect of the In-
dians and of all the decent employees on
the reservation. It is refreshing to know
that the administration saw the mistake
that had been made in his appointment
and bounced him as soon as possible.

THERE is some hope that the abuse and
persecution of the Chinese in Portland
has received a check in the decision of
Justice Wood, who last week held two
boys in \$100 bonds to appear before the
grand jury. They were charged with as-
saulting a poor old Chinese rag picker
with rocks, striking him in such a man-
ner as to destroy one eye. Boys are not

alone in this persecution. It is indulged
in by men, who ought to know better.
To be sure, they are only Chinamen, and
we are no more a lover of Chinamen than
a good many others, but if the law
against cruelty to animals was no better
enforced than the laws that include in
their scope even Chinamen, they would
be a dead letter. Such attacks are brutal
and demoralizing, and do not in any par-
ticular tend to impress the Chinese, as is
intended, with the fact that their room is
better than their company. We can never
settle the Chinese question in this
manner, and through respect for the dig-
nity of this government, as well as a
sense of decency and a feeling of humani-
ty, the proper authorities should punish
such malefactors. If the citizens of Chi-
na should treat a dozen Americans in the
manner in which the Chinese are treated
in America, they would be a stir about
the war department that would knock the
Chilian episode silly, and an outraged
people would demand a reparation that
would bankrupt the government of bi-
ased people across the Pacific.

COLLEGE Y. M. C. A.

In all the leading colleges of the east
for some years past the Young Men's
Christian Association has been the lead-
ing religious movement among the young
men and by its good influence has shaped
the destiny of many a young man. It
has been the custom among these insti-
tutions for each state to hold an annual
conference in which the delegates from
the different colleges would come together
and report the work done the past year,
and propose and discuss plans and
methods for more effective work in the
future. The influence of this movement
upon the student life of the colleges of
the U. S. has been wonderful. Com-
pletely transforming many of them. At
Yale College a few years ago there were
more "Tom Payne Clubs" than individ-
ual Christians, and parents were afraid to
send their children there to school for
fear of their learning infidelity. Now it
has over 600 Christians and the infidels
are trembling. Harvard four years ago,
had 30 Christians, now over 300. Cornell
College, N. Y., has 500 Y. M. C. A. mem-
bers, and while among its Alumni there is
not a single missionary in the foreign
field, there are now 30 volunteers in the
school. What it has done for these in-
stitutions, from this has arisen the "Stu-
dent Missionary Movement," which has
been the means of enlisting for the for-
eign field, in the last six years, more vol-
unteers than the church has sent out in
the last 150 years.

Until recently the colleges of Oregon
have been behind in this work, but about
two weeks ago the International College
Secretary, John R. Mott and the State
Secretary of California came into the
state and visiting the different colleges,
organized nine associations and called a
convention, which met for the first ses-
sion in the assembly room of the state
capitol building last Friday evening.

Present from the following ten institu-
tions: Albany College, McMinnville Col-
lege, Pacific College, Pacific University,
Portland Academy, Portland University,
State Agricultural College, State Normal,
State University and Willamette Univer-
sity. This convention was not only sig-
nificant from the fact of its being the first
held in Oregon, but it was the largest like
convention of students ever held in the
world considering the students and Col-
leges represented.

Mr. Mott, who is constantly presenting
facts and statistics, in a talk upon the
"Religious Condition of the Colleges of
Oregon," presented the following array of
facts:

From this he gathered the following
and set forth in his usual forcible manner:

1st. The number of new students for
the year is about ten times the number
converted during the year.

2nd. The number of associate mem-
bers is greater than the number converted
last year.

3rd. Only one-eighth of the non-church
members have been brought in as as-
sociate members.

4th. Only 11 per cent of college stu-
dents attend weekly religious meetings.

5th. Only one-sixteenth of students
are in special Bible study classes.

6th. Only one-half of the colleges of
Oregon have the Bible in their curricu-
lum.

7th. Only three-fifths are planning
for religious work as a calling.

8th. Only one-sixth of the college
Christian students of Oregon are looking
toward the foreign field. To one-sixth
of the Christians is left the care of twenty-
five hundredths of the human race, while
thirty-six hundredths look after one-
twenty-fifth of humanity.

One of the most interesting and able
men present was Mr. Sayford, who gave
some of the most practical and forcible

addresses that it is ones privilege often to
hear. Saturday night he gave his "con-
fidential talk to young men," which is
probably one of the best things of the
kind ever delivered, and of which Pres.
Jordan, of Stanford University said re-
cently, "every young man in America
should hear it."

besides many other interesting subjects
by forcible speakers, were treated in a
plain practical manner and which went
home to the hearts of all present. It is
safe to say that this new movement in
the college life of Oregon has come to
stay. It also has the support of the Fac-
ulties in all the different colleges. There
being sixteen college professors present at
the convention. This is the beginning of
a new epoch in the Colleges of Oregon,
and certainly no other movement could
do more toward the advancement of re-
ligious interest than may well be expected
from this. And when we remember that
with spiritual advancement comes in-
creased interest in education and that in
these two, is the hope of our government
and civil institutions. Today should we
not unite in giving it our hearty support.
