EDITH'S GRAPHIC.—Having been often asked how much rain fell this last rain, I send you the figures for the three wettest days, measured at 5:30 p. m. The 12th, 89; 13th, 1.73; 14th, 1.58; total in three days, 4.11 inches. 7.41 inches have fallen this month up to date and 22.31 inches since July 1, or about half our annual rainfall.

Close of Revival Services.
All the revival services that have been in progress in Newberg have been closed. The meetings that were in progress at Friends church for three weeks under the leadership of Rev. Elwood Scott the pastor, closed on last Sunday night. The meetings were held regularly each night at 7 and in the afternoon at 2 o'clock. Rev. Scott has proven himself to be a successful revivalist as well as an excellent preacher and pastor. His teaching was plain, practical and convincing and resulted in a fresh awakening of the membership as well as in reaching those who were making no profession of religion. A number of persons have already united with the church and others will follow at the next business meeting of the church.

Three Sudden Deaths.
We record the sudden death of three old men, citizens of this valley, this week. Mr. Rogers who died suddenly at the residence of his son R. H. Rogers, up the valley on last Saturday morning, came here three or four years ago from Minnesota. He lived in Newberg until a short time ago.

On Saturday morning Cosby Carter was found dead in bed at the residence of his son-in-law, Leonard Myers on Main street. Mr. Carter was one of the old settlers of the valley and was the father of fifteen children. His two sons Pearl and John live up the valley.

George Myers the owner of the fish pond east of town a couple of miles dropped dead at an early hour on Tuesday morning while out at work with his son Levi. Mr. Myers had been very uneasy about his fish pond for two or three days, as the fish of water, owing to the heavy rainfall, was threatening to cut around the dam which would have occasioned the loss of his fish. He had worked night and day to save it and the over exertion and anxiety was no doubt the cause of his sudden death. Although sixty-five years of age he had always been in good health.

FROM OUR EXCHANGES.
Yamhill County Reporter.

The Christian church of McMinnville will let its light shine from the walls of the midwinter fair, by means of a unique directory card. The card will contain lists of church officers and subordinate societies, and a great deal of general information about the church, the city of McMinnville and the county of Yamhill, and will be embellished by a number of photos. The conception is an excellent one and will be about as good an advertisement as any town could have.

According to general understanding the county court promised the populists a place for one of their party on the election board of each voting precinct. This has given rise to some discussion in the North McMinnville precinct, where the names of A. J. Apperson, Judge Ramsey and Dr. Baker appear in the list, as to which one was selected as a calamity.

Telephone-Register.

The secretary of state informed the county court on Wednesday that the state levy would be made on Tuesday next. He could give no approximation of the levy, but stated that it would be less than 7 mills, the levy of last year.

The county court is in session and is waiting on the state for its levy before making the levy of this county. The levy last year was 26 mills, but the commissioners think that the levy this year will be below 20 mills. None of the school districts in the county have reported to the county court the amount of their levy. The court is also discussing the sheriff's fees in the collection of the school and city taxes. They want to determine whether it is best to allow the sheriff to deduct the 2 per cent allowed him for the collection of the school district and city taxes, turning over the balance to the city and district, or to have him turn over all the money, putting in his bill for the collection of the taxes to the various cities and school districts. The expenses of Yamhill county for the past year have been less by some \$5,000 than the average expenses of the county for the three previous years, and unless one or two bridges go out during high water the expense of the coming year will be less than that of the past year.
