TELEGRAPHIC RESUME

Events of the Day in a Condensed Form.

OF INTEREST TO ALL READERS

(Items of Importance From Domestic and Foreign Sources—Cream of the Dispatches.)

Portland, Or., experienced a single earthquake shock of brief duration.

Two massive boilers of the Planter's oil mill in Greenville, Miss., exploded, wrecking the mill property and causing the death of five men.

It is asserted that the Transvaal government is about to offer England the assistance of the burgher forces to crush the Matabele uprising.

Ten persons were burned to death in a fire at 36 Union square, Brooklyn.

The building was a four-story tenement-house, occupied by Italians.

A train on the St. Louis and San Francisco railroad was held up by masked men three miles from Lebanon, Mo. Express officials say that they secured but \$1,277.

Frederick A. Humphrey, said to be the oldest Freemason in the United States, died in Janesville, Wis., aged 95. He belonged to the Masonic fraternity for 74 years.

The garment workers of Baltimore, who have been on strike for five weeks, have returned to work where they could get their places. Over 6,000 persons have been out.

The Missouri supreme court has affirmed the sentence of the Taylor brothers, charged of having murdered the Meek family, near Milan. Execution was set for April 30.

The president has appointed B. F. Franklin, a former member of the house, as governor of Arizona. The term of the present governor does not expire until April 1, 1897.

Mme. Dore Berthel, a leading contralto of Louisville, Ky., one of the best-known vocalists of the South, has been stricken blind, and the probabilities are that her affliction will be permanent.

In his annual message, President Diaz, of Mexico, vigorously upholds the United States in the stand it has taken in the Venezuela matter and expresses his partiality for the Monroe doctrine.

In Victor, Colo., Edward Caskey was killed and Joseph Wigand was fatally injured by an explosion of giant powder, they were thawing on the cookstove at their mining claim on Prospect Hill.

In Prague, strikers attacked the weavers who had resumed work, and a serious conflict took place. Finally the police were compelled to charge with drawn swords and several persons were wounded.

A New York Herald dispatch from Rome says the negus Menelek has ordered the massacre of a number of prisoners and sick persons who have fallen into the hands of his forces during the present campaign in Abyssinia.

Judge Hanford has granted an order for the sale of the Seattle, Lake Shore & Eastern railroad, the sale to be made in Seattle on or after May 16 next. The bondholders, under the reorganization plan, will be bidders for the property.

Hereafter the Northern Pacific will run two transcontinental trains instead of one. The time between St. Paul and Portland will be shortened eight hours by putting on a fast mail train. The time eastbound will be shortened six hours.

Senator Davis, of the judiciary committee has reported favorably the bill making it unlawful to shoot or throw any missile into any railroad locomotive or car, or to shoot at any person therein. The bill has particular application to the Indian territory.

It is now known that one-half of the Texas peach crop has been killed by frost. Corn has all been planted, but as yet no cotton, although the ground is prepared for it. Owing to the late season, caused by cold winter, the acreage will not be so large as last year.

A special to the New York Herald from Madrid says a violent attack upon Senator Sherman was published in the Imperial, which called him a former slave-trader, and asserted that he wants the Cuban rebellion to succeed in order to re-establish slavery in Cuba.

The Cotton Silk Manufacturing Company, of West Bethlehem, Pa., has made an assignment to ex-Postmaster John Field, of Philadelphia. The failure is a heavy one, as the company is capitalized at \$500,000 and has, in addition, a bonded indebtedness of \$100,000.

T. Simon Sam, formerly minister of war for Haiti, has been elected president to succeed General Hippolyte, deceased. The election was held by the senate and house of representatives. Perfect tranquility prevails, and there are no indications of dissatisfaction with the choice of the executive.

Secretary Morton has let a contract for 10,125,000 packets of vegetable seeds, to be distributed under the recent act of congress, to D. Landreth & Sons, of Philadelphia. The price is \$70,000. The seeds are to be delivered ready for mailing. The contract for a million packets of flower seeds was let to L. L. May & Co., St. Paul, Minn., at half a cent a package.

The Chicago board of election commissioners has declared that 45,000 of the 370,000 voters registered for the coming spring election are fraudulent. The commissioners discovered whole-

sale registration frauds in nearly every ward. They say the number of names stricken from the lists is "greater than the total vote cast in Montana, North Dakota, Delaware, Florida and Nevada."

Three men boarded the eastbound train No. 1 at Truckee, Cal., taking positions on the "blind baggage." It appeared that they were standing on the platform in a careless manner, and when the train was rounding a curve near Boca, a lunch threw them off.

One of them, William Morse, whose home is in Tacoma, was killed. R. F. Evans, of Chicago, was badly injured. The third man was not injured.

A move has developed in Nebraska to contest the right of the government to regulate the liquor traffic of the forts in this state. At every post the "canteen," operated by privates, is conducted without state or county interference.

At Fort Robinson county authorities issued warrants against the canteen owners, for selling liquor without a license, and wrote to confiscate the wet property. The military authorities refused to permit the sheriff to serve his warrants and that official has appealed to the secretary of war.

The Chinese government has decided to enter the postal union.

H. E. Topping, a furniture dealer of Astoria, committed suicide by blowing his brains out.

The schooner J. B. Leeds is long overdue at Gary's harbor from Guaymas, Mexico, and great anxiety is felt for her safety.

The London Times correspondent in Vienna says: The Vaterland publishes a communication from the superior of the Catholic station at Orfa, declaring that 8,000 Armenians have been massacred there.

The money order transactions throughout the United States during the last quarter of 1895, beat all previous records in volume. The accounts have just been audited and show the receipts to have aggregated \$15,575,971.

A foreign dispatch says: It is believed the derrives lost 5,000 dead, wounded and prisoners in the engagement at Mount Moeran on April 2, with the Italian native battalion commanded by Colonel Stevens from Casala.

Fire broke out in the Washburn & Moen Manufacturing Company's plant, at Quincy, Mass., resulting in a loss of from \$150,000 to \$165,000, fully insured. Two hundred men will be out of work until the building is rebuilt.

The Genesee river is higher than in twenty years. It is over its banks in the southern part of Rochester and has washed away part of the Erie tracks. The houses are surrounded by water and the occupants have had to desert their homes.

Arthur Bradley and Richard Ingraham, two factory hands employed in Haverhill, Mass., engaged in a prize-fight, and as a result the latter was killed by a blow on the jaw. The fight was to be a friendly one to settle the title as to who was the better man.

A novel measure, aimed at high theater fires, was enacted into law by the Ohio legislature. It provides that any manager permitting any person to wear a hat or other headgear in a theater obstructing the view, shall be guilty of misdemeanor, and shall be fined \$10.

William Kemper and John Limpke, of Ohio, Ind., engaged in a friendly contest for boxing supremacy in a saloon at that place. After a few passes, Kemper struck Limpke in the abdomen. The injured man fell unconscious, and remained so until he expired soon after.

It has been announced that a chair of the Russian language will be established at Harvard next year. Professor Leo Weiner, of the University of Minnesota, a native of Poland and a well-known scholar of the Slavonic tongues, has been appointed to the chair for five years.

Edward Davids, a prominent farmer of Cox Lake, was shot and instantly killed by Julius Zilke, a farmhand working for him. Davids had interfered to prevent Zilke from striking a young man in a quarrel, and Zilke wanted for Davids to come home, when he shot him in the presence of Davids' wife.

John Selman, the victor of no less than twenty fatal shooting affrays in Texas, the exterminator of "bad" men, and the slayer of the notorious John Wesley Hardin, was shot and killed by United States Deputy Marshal George Scarborough. The men had a quarrel over a game of cards, which resulted in the shooting.

Letters received from Rainy river, on the Canadian boundary, report the death in Rainy river of the entire party who accompanied Colonel A. F. Naff, United States special agent. They were on the way to investigate a report of timber stealing by Canadians, and were ascending the river in sleighs. They broke through the ice and all but Colonel Naff were lost.

At a meeting of the bondholders of the Northern Pacific railroad held in Berlin, it was unanimously resolved to accept the reorganization plan. The Northern Pacific plan of reorganization has been adopted by two meetings, one of third mortgage bondholders, representing \$4,971,000 out of \$7,845,000, and one of second mortgage bondholders, representing \$5,844,000 out of \$9,448,000.

There has been considerable rivalry between the masters of the sailing vessels plying in the coal trade between San Francisco and Nantam for the past year, and some very fast passages have been made, several of them inside of twenty days. The Wilna, Captain Slater, arrived at San Francisco, making the round trip in sixteen days and four hours, which is by far the best time on record.

AT ST. THOMAS' CHURCH

Marriage of Gen. Harrison to Mrs. Dimmick.

THE AFFAIR WAS A PRIVATE ONE

After the Ceremony, the Couple Left for Indianapolis—The Bride's Wedding Gown.

New York, April 8.—The marriage of Mrs. Mary Lord Dimmick to General Benjamin Harrison was solemnized at St. Thomas' church this afternoon at 5:40. Dr. Wesley Brown, the rector, officiated at the ceremony.

The marriage which took place in the presence of twenty relatives and select friends of the bride and groom, was a very private affair.

The edifice was not decorated in the lavish style that marked the nuptials of Miss Vanderbilt and Miss Whitney, the two most important weddings of the season, but the flowers used, lilacs and ascension lilies, were arranged with exquisite taste and the chancel looked even prettier and more effective than at the two previous weddings.

Mrs. Dimmick arranged all the details regarding the decorations. The altar was relieved with palms, tropical plants and banks of white lilacs surmounted with bunches of ascension lilies.

General and Mrs. Harrison, after the ceremony were driven to the residence of Mr. and Mrs. Pinchot, and at 7 o'clock took the regular train for Indianapolis, occupying the private car of President Frank Thompson.

Immediately after the train pulled out, dinner was served on the coast.

Mrs. Dimmick's wedding gown, which was of pearl-gray gros grain silk was made by Mme. Denoit-Mathie. The skirt was plain, with a short train falling from the waist in full, soft folds.

A Louis XVI coat, opening in front over a full vest of white chiffon, with broad revers, draped with rare old Honiton lace, half a yard in width, extending down each side of the front and draped over the hips, formed a coat effect. The sleeves were long and full, tapering to the arm below the elbow and extending in a fall of lace to the wrist. Around the neck there was a plush collar of palest blue velvet, over which was entwined a rope of magnificent pearls, fastened with a diamond clasp, the gift of the bridegroom.

She carried a large bouquet of lilies of the valley. The bonnet worn by the bride was a dainty French creation, composed of lace and blue velvet, held in place by jewel pins.

The groom wore a well-made Prince Albert coat, worn closely buttoned, with trousers of dark grey. White gloves and a white silk four-in-hand completed the bridegroom's attire. He wore a boutonniere of lilies of the valley.

ONE DOLLAR WHEAT.

Armour Says This Price Will Be Reached in the Near Future.

Chicago, April 8.—P. D. Armour said in an interview today: "I believe that wheat will sell at \$1 a bushel or near that figure soon. This is speaking from the standpoint of a merchant, and not as a sealer. It ought to sell here on its merits, and will, unless something new unforeseen occurs. I have felt bullish for several weeks, but never more so than now. What any individual or operator says, has no reference to the actual market conditions. The advance will not be a matter of sentiment, although I believe business men all over the country are becoming more confident and cheerful. This grain may be singled out for improvement. I believe that all other products will be helped. Corn and oats may sell up a few cents, although conditions of supply and demand are entirely different in them than in wheat, but provisions are at a range of prices where they are sure to be better."

BALLINGTON HOLDS OUT.

The Meeting With Mrs. Booth-Tucker Was Without Effect.

New York, April 8.—Ballington Booth and his sister, Mrs. Booth-Tucker, had a protracted conference lasting from 10 o'clock last night until 4:30 this morning in Ballington Booth's residence at Montclair. There was no result of the conference, but it is understood the estrangement between Mrs. Booth-Tucker and Ballington to return to the Salvation Army were without effect. A conference was held at the Salvation Army headquarters in this city today, there being present the Booth-Tuckers, Commissioner Carleton, Major Melan and Secretary Lewis.

The following statement was made by Commander and Mrs. Ballington Booth in the headquarters of the Volunteers:

"We are, however, anxious to have it clearly stated that this interview was of a sisterly and brotherly character, and apart from the matters in controversy, on which we must differ, there exists with us, as there always has, the warmest affection for Mrs. Booth-Tucker as a sister."

Down an Embankment.

Cahto, April 8.—The Ukiah & Eureka stage, leaving Ukiah shortly after dark last night, toppled over an embankment twenty miles south of here. Driver Ethelbert Whitcomb was evidently instantly killed. When found this morning, his body was burned beyond recognition, one leg and both arms having been burned off. The stage was turned bottom side up, the driver being caught underneath the stage which was heavily laden with express and mail matter, all of which is a total loss. Whitcomb was unmarried, and resided at Ukiah.

RAID ON FISH TRAPS.

The Astoria Fishermen Set a Number of Them Adrift.

Astoria, April 6.—A number of fishermen of this city made a raid on the fishtraps south of Sand island, in the vicinity of Baker's bay, this morning, and, with the aid of a snapper belonging to the Fishermen's Protective Union, the piling of a number of traps were drawn, and several pile-drivers were wrenched from their moorings and sent adrift over the bar into the ocean. The affair caused intense excitement among the trap owners and custodians. An ineffectual attempt was made to prevent the destruction of the property. It is supposed that the cause of the act was the recent combination formed among the cannerymen here, and the resolution reducing the price to be hereafter paid for raw fish, the fishermen evidently being determined to hold out for high prices, and to prevent, meanwhile, the canning of fish caught in traps belonging to the cannerymen.

The fishermen's drift is pretty well resisted the attempt of trap men to locate their traps near what is known as the cut-off channel. This channel is near the Great Republic spit, and for some years has been a favorite drifting ground. The location of traps, the fishermen claim, would quickly destroy its value and menace the lives of all who should drift in that direction.

The action of the fishermen in casting the pile-drivers adrift is pretty generally deplored, but the pulling of the piling funds almost unqualified approval among the members of the union, and no little indorsement among the citizens generally.

LAND CASES DECIDED.

Two Decisions of Interest to the Northwestern People.

Washington, April 6.—Secretary Hoke Smith has reversed the action of the general land office in the case of the United States vs. P. J. Lynch and W. D. Gilbert, transference, involving a pre-emption cash entry in the Seattle land district in Washington. The general land office, on the strength of a special agent's report, had held his entry for cancellation for non-compliance with law in the matter of residence and improvement on the land.

This was reversal of the ruling of the local officers, after a hearing.

The secretary says that a careful consideration of the whole evidence, and of the record, fails to show such a want of good faith as would warrant the cancellation of the entry in the absence of any adverse claim, and the burden of proof was on the government.

Another reversal is made in the case of E. C. Masten, who made a timberland entry in the Oregon City, Or., district. Masten claimed under oath that his entry was cancelled because the land, although heavily timbered, yet, when cleared of its timber, could be made fit for agricultural purposes. Secretary Smith says that, so far as the general land office decision was based on that allegation, Masten's entry was improperly cancelled.

Delinquent Tax Lists.

Olympia, April 6.—Judgment has been affirmed by the supreme court in the case of the state of Washington, ex rel. Whatcom county, appellant, vs. E. W. Purdy, treasurer of Whatcom county. This was a proceeding in mandamus to compel the respondent, as treasurer, to furnish the delinquent tax list required by law to be published in April, 1896, in the county official newspaper. The commissioners of that county had designated the Champion as the official organ, and had made a contract with that paper to do the county printing. Treasurer Purdy denied the commissioner's authority to enter into such a contract; claimed the right to have the delinquent tax list published in any county paper he chose, and made a contract with the Revelle, in February, 1896, to publish the list. Also, the respondent's answer showed that a contract was entered into by the board of county commissioners in June, 1894, to have the printing done by the Revelle, including delinquent tax lists. The supreme court is of the opinion that the law, as it now stands, fully empowers the treasurer of the county to select any county paper to publish the delinquent tax list.

Swept by Flames.

Brunswick, Ga., April 6.—Several years ago this town was visited by a conflagration which destroyed it, and today the disaster was almost repeated. A fire started about 10:30 A. M., which swept away many of the most prosperous enterprises of the city, and for a time it was feared the whole town would burn. The loss is about \$500,000, and the insurance is placed at \$400,000. The flames started on the Brunswick & Western railroad wharves, and within an hour, the wharves, two large warehouses and a number of cars, including the freight contained therein, were consumed.

A special report to La Prensa states that the situation among the Santa Fe colonists in Buenos Ayres is desperate. They are without means and almost without food. The commercial firms are in terrible straits. The national congress will attempt to succor the people until the next harvest.

The linen furniture covers once deemed indispensable summer adjuncts are now replaced by more artistic ones of cretonne.

PORTLAND MARKETS.

San Francisco produce is being well received here, and finds a ready market at firm figures, cabbage alone suffering a depression. Butter is much weaker, and quotations are 5c lower. Eggs are offering freely and quotations range between 8 and 9 cents. Sugar advanced a fraction on all grades. Chickens are firm with an upward tendency.

Wheat Market.

There is no change in the local wheat market, the Chicago fluctuations of the past few days having but little effect here, where prices are governed by the foreign markets. Prices of wheat in Portland are: Walla Walla, 55 to 56c; Valley, 58 to 59c per bushel.
