Memphis, Dec. 29.—A special to the Commercial Appeal, from Birmingham, Ala., says: Friends in human form wrecked the Birmingham Mineral passenger train No. 4 at Cahaba river bridge, twenty-seven miles from here, at 7:30 this morning, and twenty-two lives were lost. That number of bodies have been recovered, and further search may swell the list of dead. The wreck is regarded as almost certainly accomplished by the removal of a rail on the middle span of the trestle. This derailed the train, which caused it to fall down the two spans and precipitated it into the river, 110 feet below. The wreck was the worst that has ever occurred in the state, and the survivors are so few and so badly hurt, that they are unable to give any detailed description of how it happened.

He appealed to them to leave the punishment of the crime to the state. As citizens of the capital of the state, he implored them not to permit, in the very shadow of the capital, such a crime as was contemplated. When the enraged men were finally induced to withdraw, the prisoner was removed to the state penitentiary. Armed guards from the state army assisted in the transfer of the prisoner.

New Orleans, Dec. 29.—The steamer Quensmore, Captain Gross, from London, arrived today, having on board Captain Tobiasson and son, mate and crew of the Norwegian bark Neptune, picked up on December 9, in latitude 45, longitude 13 west. The bark had a crew of nine men, all told, and was from Belize, Honduras, bound for Havre, with a cargo of logwood. When abandoned there was ten feet of water in her hold.

PERISHED TO A MAN.

Brave Party of Texans Fighting for Cuba Killed in a Hot Fight.

New York, Dec. 29.—A special to the World from Key West, says: The Lone Star company, of the Patriot Army of West Cuba, consisting of fifteen Texas sharpshooters, perished to a man after battling more than five hours against vastly superior Spanish forces in Pinar del Rio province, killing double their own number and wounding probably as many more.

RETURN OF ANDRADE

Venezuelans Satisfied With Boundary Treaty.

Minister Declined to Talk No Indications of Coming Trouble in President Crespo's Republic—Lawyer Storror's Views.

New York, Dec. 29.—Senator Jose Andrade, Venezuelan minister to the United States, accompanied by James J. Storror, counsel for Venezuela before the United States boundary commission, arrived in this city this afternoon on the steamer Caracas and left for Washington tonight.

WRECK ON A TRESTLE.

An Alabama Passenger Train Plunged Down One Hundred Feet.

Memphis, Dec. 29.—A special to the Commercial Appeal, from Birmingham, Ala., says: Friends in human form wrecked the Birmingham Mineral passenger train No. 4 at Cahaba river bridge, twenty-seven miles from here, at 7:30 this morning, and twenty-two lives were lost. That number of bodies have been recovered, and further search may swell the list of dead. The wreck is regarded as almost certainly accomplished by the removal of a rail on the middle span of the trestle. This derailed the train, which caused it to fall down the two spans and precipitated it into the river, 110 feet below. The wreck was the worst that has ever occurred in the state, and the survivors are so few and so badly hurt, that they are unable to give any detailed description of how it happened.

RAKED BY SOLID SHOT

Thrilling Adventures of the Steamer Three Friends.

Chased by Spanish Warships The Filibuster Fired Upon and Disabled an Armed Coaster—Landed Her Men and Supplies.

New York, Dec. 28.—A World special from Key West says: The lone-star flag of Cuba has met the red and yellow banner of Castle upon the sea. The sharp, shell and rifle volleys of a brave filibuster have made answer to the roar of Spanish twelve-pounders, and have gained for Cuba Libre the first victory on the ocean.
