JEALOUSY OF THE UNITED STATES.

Europe, in the largest sense, would not regret an end of the war unsatisfactory to the United States, and quite a number of the larger powers will exert what pressure they can to bring about that result. Austria is known to be hostile and restrained only by considerations of prudence. Italy is greatly disturbed by industrial and political troubles. The advance in breadstuffs has caused serious riots and the Italian Cabinet dreads the continuance of war and too sweeping success for the United States. The German Emperor is ambitious for the aggrandizement of Germany. He does not look with favor upon the commercial advancement of this country, and his policy has been to discredit our goods as much as possible in the world's markets. He is not a believer in the Monroe doctrine, it is not thought that Russia could be induced to depart from its traditional friendly policy toward us, but it cannot be assumed that the czar, as a principle, approves of wars waged in humanity's name to rescue an oppressed people.

France especially is in a bad humor. It is heavily interested in Spanish securities and trade, and the exhaustion of Spain, with the loss of its colonies, means a serious inroad upon French wealth. The comment of the French press has not been complimentary to America and Americans for several months. Many small French investors hold Spanish bonds and numerous tradesmen feel the absence of American tourists. Dear bread has its dangers for France as well as for Spain and Italy. In a diplomatic sense France sees with deep concern a drawing together, for the first time, of the people of England and of the United States. France is weakened where it has been strong ever since the days of the American revolution. Lord Salisbury's speech at the bankers' banquet in London a few nights ago showed more friction between England and France than has been supposed to exist. The British Premier, referring to French negotiations, spoke of the necessity of looking facts in the face and being thoroughly prepared to discharge the serious duties which the course of events may impose.

The United States has not departed from its policy of keeping out of European politics. We are at war with a European country for its atrocious treatment of an American colony almost in touch with our borders. It is our right and duty to strike this enemy in any of his possessions. The Spanish will do us all the harm they can wherever they can. Such is the well-defined province of war. Our attack on Manila was not dictated by territorial. It was a strategic and commercial necessity. It is not our fault that bread is growing dear in Europe. Fighting in the United States is sure to be attended by that disadvantage for a crowded population consuming more food than it raises. We are attending to our own business, and not in the slightest degree attempting to regulate the internal affairs of that continent. But we must expect, from the spirit shown since the outbreak of the war, to encounter the jealousy of certain powers. Fortunately, we are able to protect ourselves from their animosity and to settle the war on lines that will endure.—Globe Dem.

Hawaii in the Present Crisis.

Whatever slurs may have been cast upon the missionaries and the "sons of missionaries" in the Hawaiian Islands, we beg to assert that this country has produced no group of men of whom we have greater reason to be proud than the men who are today controlling and administering the Hawaiian republic. The Sandwich Islands have been added to Christendom and civilization by American efforts. Whether we annex these islands or not, their peculiarly intimate connection with the United States must have been made a permanent fact as a result of the present war. They have long needed us for the sake of a stable domestic equilibrium. We now perceive that we need them as a strategic outpost. The gentleman who have been so bitterly opposed to Hawaiian annexation are now facing what seems to them the more dreadful bog of Philippine annexation. We would modestly suggest to them that inasmuch as compromises are the necessary rule of practical statesmanship, they might do well to abandon their opposition so far as the Hawaiian group and the Caroline group are concerned—both groups having actually been transformed from savagery to civilization by American effort. Their antagonism to Hawaii has been so violent, and in some respects so unreasonable, that it has not only overreached itself, but has really provoked a reaction of public opinion under which we may be led a great deal too far in the opposite direction of annexing everything we can lay hands upon. The predominant opinion of thoughtful men now seem to be that we want to hold the Hawaiian Islands as a permanent position, but we want to get out of the Philippines as soon as we can safely and honorably withdraw. "All during Mr. Cleveland's two terms as president Mrs. Cleveland's most intimate associates were those whom she knew before marriage," says a writer in the June Ladies' Home Journal. A fourth was the teacher of a small kindergarten, who, when the Cleveland children reached a suitable age, transferred her to the White House, and the children and grandchildren of the Cabinet members, and of the families of Mrs. Cleveland's friends, and of the friends of the President, became her pupils. The only official favor which Mrs. Cleveland asked of her husband while he was president was the appointment to office of the husband of her college roommate."
