This also applies to factories and fruit evaporators, and state and county buildings and institutions, and may in the near future result in the use of different kind of fuel by some.—Dayton Herald.

Medical Inspection of Schools. Among other Yankee notions that have been introduced into the public schools of Boston is a daily medical inspection. The city employs for this service 50 doctors at a salary of \$200 a year. It is stated that bright young members of the medical profession are glad to accept such appointments, and it can readily be seen that such an introduction into business may be advantageous. The work occupies but a small part of the day. During the last school year this inspection disclosed 500 cases of specific infectious diseases, while 3,000 pupils were sent home. The list of diseases discovered included 200 cases of mumps, 169 cases of measles, and 175 cases diphtheria, scarlet fever, whooping cough, chicken-pox, and influenza. Diphtheria is now extremely prevalent among the school children of Worcester, and the Worcester Telegram urges that the Boston plan be applied in that city. "Ten physicians it says, ought to be able to make the rounds of Worcester schools if fifty can cover the ground in Boston, and \$2,000 will be wisely spent paying them." We do not know just how much time is devoted to the daily inspection or whether it includes all the scholars or only such as seem, from general appearance, to need attention. If it could be so managed as not to interrupt the regular progress of school work, it would be desirable in the schools of all cities. The cost would be trivial in proportion to the probable results.—Washington Post.

Out of the Ordinary. A Russian does not become of age until he is twenty-six. A German law prevents proprietors of eating houses from serving beer to people eating fruit. Cyclists in Denmark are forbidden by law to ride faster than the speed of a cab through any town. St. Petersburg has the largest bronze statue in existence—that of Peter the Great, which weighs 1000 tons. South Dakota has a surplus of money in the state treasury. It recently took up \$70,000 of bonds not due until 1910. A millionaire who died in Boston a few days ago directed in his will that no one owing him less than \$3000 be required to pay. In Siberia, if a man is dissatisfied with the most trifling acts of his wife, he tears a cap or veil from her face, and that constitutes a divorce. A book published in Japan a thousand years ago notes that at that time good silk was already produced in twenty-five provinces of that country. An English guidebook makes the curious assertion that a large proportion of those who have made the ascent of Mont Blanc have been persons of unusual mind. According to the authority of an English magazine Great Britain controls 21 out of every 100 square miles of the earth's surface, and 24 out of 100 square miles of territory in North and South America. In northern China many of the natives are dressed in dogskin. There are many establishments where dogs of a peculiar breed are raised in large numbers for their shaggy pelts. They are killed when eight months old. Faneuil Hall has fallen into such a dilapidated condition that a guard has been stationed on the second floor of the building to warn visitors away from weak spots in the flooring and to keep them from leaning against the rotten posts that support the gallery. The building is soon to be reconstructed. A Russian officer has been making experiments with very successful results, in the use of falcons instead of pigeons as carriers. It seems that they can fly much faster. A pigeon covers ten or twelve leagues an hour, whereas a falcon can do fifteen. It can also carry with ease a fairly heavy weight. The wine cellar of the old Chaldean King, Argastus II, has been discovered near Lake Van, in Asia Minor. It was filled with colossal earthenware vessels, some of which have been sent to the Berlin museum. An eminent Indian medical officer is satisfied that the growth of sunflowers in malarial soil is better than eucalyptus as a preventative of malaria. The government of India is making extensive experiments to determine this point. In ancient wars it was the regular custom for both armies to go into winter quarters, but nowadays such a thing is quite unknown, and several battles during this century have been fought on Christmas day and New Year's day. The soldier boys at Manila say that Spaniards and natives there invariably turn to the left instead of to the right in passing others on the sidewalks on the streets, and consequently there are numerous accidental collisions with Americans. John Muir makes a strong protest in the current Atlantic Monthly against the wholesale destruction of robins about the Bay of San Francisco. "Song birds for food!" he exclaims. "Compared with this, to make kindling of our pianos and violins would be pious economy."
