Bryan overleaps himself as usual when he tirades against the maintenance of a standing army. Does he expect the country to put absolute dependence in the type of citizen soldier that he turned out to be in time of emergency?

Senator (?) Clark of Montana is now in a good position to appreciate the old proverb to the effect that a good name is rather to be chosen than great riches—that is when seeking entrance into the United States Senate.

The First District declared Tuesday for the best interests of the state, by the re-nomination of Congressman Thos. H. Tongue. He was "remembered by what he has done," and it is refreshing to know that this is still considered a valid recommendation, even in Oregon politics.

The county democratic convention met last Saturday and adopted some "ringing" resolutions, among which the words "oppose, denounce, and condemn" figured most prominently. But come to think of it, there is nothing strange about it. Bryan "had just come to town" and they were playing at the old game of "follow the leader."

Admiral Dewey, when accosted the other day by reporters for an interview, said he had nothing to say, and thereupon introduced his wife with the remark, "Mrs. Dewey will talk." These words are few but very suggestive of the source of the brave old sailor's troubles. The old adage is not yet outlawed that "There's no fool like an old fool," especially when he is in the hands of an over ambitious woman.

The gallant General Wheeler presents at least one popular idol which remains unbroken. When approached on the subject of vice-presidential aspirations he replied, "The greatest ambition of my life has already been realized. I have seen those who were once confederate soldiers fight under the Stars and Stripes against a foreign foe as soldiers of the United States. The realization of conditions so advantageous to our country, fills the measure of my desires, and beyond that I have no ambition whatever."

In Iowa city elections Tuesday, the democrats elected mayors in Des Moines and Burlington and the republicans elected mayors in Clinton and Sioux City. The results show large republican losses in all instances.—Roseburg Review.

Even if true, the last statement would contain cheap comfort, as everybody knows Iowa can do nothing else but republican. But hasn't the Review "accidentally" omitted some interesting political news? How about Nebraska, Bryan's own state, for instance? And Lincoln, Bryan's own city? It looks much as if the boy orator would soon have to refer to his own home as "the enemies' country."

Who should be able to judge best in regard to the ability of Senator McBride? The prejudiced, factional and would-be dictatorial people who can't "manage" him, or Senator McBride's illustrious colleagues, who come in contact with him every day in the United States Senate? The judgments of the former we "have with us always," but in this issue we give some unprejudiced opinions of the latter. Sensible and fair-minded people will know how to separate the wheat from the chaff, especially as they have had enough of the latter thrown in their faces of late to be able to recognize it.

If Newberg will donate 50 acres of land for a site and can secure pledges from farmers to plant and cultivate 5000 acres of beets, she is promised a sugar factory costing \$600,000 to \$800,000. We are satisfied she will meet the conditions, for Newberg is an enterprising town and has a class of people who can look at a proposition of the kind from a broader standpoint than merely the question, "what will it profit me in dollars and cents?" The spirit of town pride and ambition has a hold on them, and they will donate their energy and their dollars to the purpose of making Newberg a thriving and prosperous city of the best possible character. Her people believe in Newberg and are willing to work for and spend their money for her, and next to religious sentiment, that of home pride and public spiritedness stands high up in the catalogue of human virtues.—Sheridan Sun.

THE REAL IMPERIALISTS

In an article written since returning from the Philippines, Gen. Wheeler remarks that Aguinaldo was fighting for a great prize, and "had he won, he would have been a powerful emperor, a mighty dictator." The true imperialistic movement is located by this statement. Its head was Aguinaldo. The government he intended to form would have been a despotism and forced upon fifty unwilling tribes. His only schooling was in Spain's form of government. He would have had a state church. His edict, a would have been supreme. Large accumulations of products had been

gathered by his agents at various ports to fill his treasury. Spanish prisoners were held for ransom. Rates of taxation would have depended on a stroke of his pen, and his method of collection is with a file of soldiers. Gen. Wheeler has seen the islands and studied the situation for himself. He believes that Aguinaldo would have been an Oriental dictator, an emperor.

Instead of pursuing a course of imperialism, the United States has struck down a Malay imperialistic conspiracy. Yet a large portion of the Democratic party favors the withdrawal of the American flag from the Philippines and the transfer of the reins of government to the Tagals. There is not the slightest evidence that the Tagals would or could form a free government, or that they would consent to be instructed or "protected" beyond the moment the American flag was pulled down and the last of our troops sailed away. Not one of the Tagal leaders ever lived in a republic or was trained in republican ideas. They have played their cards for an empire in the Pacific, and directly in our path of intercourse with Asia. But they have lost, and the only imperialism proposed has gone down with them.—Globe Democrat.

SENATOR McBRIDE'S RARE ABILITY

Prominent U. S. Senators testify to his high standing in the Upper house of Congress.

Considering the fact that a great deal of spiteful and underhanded work is being done against our senior United States senator, and that efforts are made to throw discredit on his ability, and work, the Statesman, through its Washington correspondent, has interviewed many of the prominent U.
