Hoskins for county recorder by the republican county convention held last Tuesday. Mr. Butt acquitted himself with credit at the last session of the legislature, and having gained much by experience, will be much better fitted for the responsible position at the coming session. J. L. Hoskins is one of our best citizens, and beside being well qualified for the position to which he aspires, he is entitled to the place if long years of faithful service for the republican party counts in a candidate's favor. A number of voters outside his party have already stated that they intend to vote for him at the polls.

There is a difficulty to locate some people in politics this year, as usual. For instance, J. C. Cooper was last week enrolled as a democratic delegate from South McMinnville precinct. At the populist convention in this county he was made a member of the fusion advisory committee and sent as a delegate to the state convention. At Portland he was chosen by the state central committee of the so-called "silver republicans" to go to Kansas City and whip it up for Bryan. Which party does he belong to? There is, in fact, no such thing as a silver republican, and if we were a populist or democrat we would demand that Mr. Cooper renounce all things republican before he could train with us. We would suggest as a cartoon for Mr. Cooper's "Campaign" an attempt to locate the true political affiliation of the editor. Admiral Dewey might be worked into the picture also. The job would certainly keep the artist busy.—Reporter.

COUNTY REPUBLICAN CONVENTION.

Harmony and Candidates in profession and a strong ticket nominated.

The republican nominating convention held in our county seat Tuesday was something of a record breaker in the harmony which prevailed throughout and the expeditious manner in which the satisfactory results were obtained.

The convention was called to order about ten o'clock in the forenoon, by Judge J. E. Magers, of McMinnville central committeeman. Temporary organization was effected with Judge Magers as chairman, D. H. Turner of Newberg, secretary and Frank Adams of McMinnville, assistant secretary. Committees were appointed by the chairman as follows: Credentials, J. P. Irvine, McMinnville, Lee Laughlin, North Yamhill, Jesse Edwards, Newberg, A. H. Denny, LaFayette and J. M. Crawford, Dayton; Permanent organization and order of business, G. S. Wright, McMinnville, G. M. Allen, Amity and E. H. Woodward, Newberg. Upon the adjournment of the convention until one o'clock, the delegates met and nominated precinct officers. North and South Newberg, Dundee and West Chehalis nominated J. M. Wright for Justice of the Peace and J. J. Woods for constable.

Upon re-assembling in the afternoon, nomination of a county ticket was taken up after the adoption of the reports of the committees on credentials and order of business. A. L. Myers of West Chehalis, Isaac Dougherty of Sheridan, F. H. Storey of Newberg, P. P. Olds of LaFayette and G. Detmering of Dayton were appointed as tellers.

For representatives, Clarence Butt of Newberg was nominated by Prof. J. C. Hodson, and E. F. Lamson of Willamina, by J. W. Watts. The nominations were made those of the convention by acclamation.

For sheriff, J. W. Bones of Sheridan, W. G. Henderson of McMinnville, and E. A. Alderman of Dayton were nominated. The first ballot stood Bones 15, Henderson 75, Alderman 74. Bones withdrew and Alderman won on the second ballot, receiving 89 votes to 74 for Henderson.

For clerk J. H. Nelson was nominated by acclamation.

For recorder seven nominations were made, the leading ones receiving on the first ballot, C. B. LaFollet of Sheridan 18, J. L. Hoskins of Newberg 71, Sherman Foster of Willamina 26, A. E. Lambert of Dayton 10, Nichols of Bellevue 31. The second ballot, LaFollet 10, Hoskins 82, Foster 30, Nichols 39, gave the nomination to J. L. Hoskins. Nichols and Foster, defeated candidates, generously moved and seconded that the nomination be made unanimous. Mr. Foster made an able and loyal speech in favor of Mr. Hoskins which was heartily received.

For assessor, J. M. Yocum of Sheridan was nominated on the first ballot against E. M. Henderson, the vote being 130-31.

For school superintendent E. V. Littlefield of McMinnville was nominated by acclamation.

For commissioner Geo. Vinton and Amos Nelson both of West Chehalis were nominated, Nelson winning on the first ballot, with a vote of 92 to 66.

For treasurer, O. O. Rhude of North Yamhill, and H. Gabriel of McMinnville were the nominees, Rhude win-

ning on the first ballot with a vote of 85 to 75.

For surveyor, C. E. Branson of Sheridan won against E. D. Green of McMinnville, on the first ballot, the vote standing 102 to 55.

For coroner, J. M. Chapman of Sheridan won against T. B. Cummings of Newberg on the first ballot, with a vote of 82-62.

The convention ratified the nominations made in the morning for precinct offices and adjourned.
