When an opposition paper has to go back and scare up the ghost of the "canned beef" sensation for anti-republican campaign thunder, it makes a tacit admission that it is in hard lines for something to make a kick on. Verily it is hard to kick against the pricks.

If you have ever felt like doing a good deed for the community and for yourself and posterity at the same time, subscribe liberally when canvassed for sugar beet acreage. Double or even triple the pledge already made, rather than let this magnificent opportunity go by default.

We have not yet seen any credit given Mark Hanna for casting the deciding vote against Quay in the Senate. Every fight we have is directly attributed to the encouraging given the enemy by these men, and every one of our men killed owes his death to them, for Aguinaldo is whipped, and knows it, and only hangs on desperately, hoping that his 'friends' will manage some way to help him out and not realizing that only a few men are making all the noise. It would be different if he was really fighting for liberty. He is fighting for the supremacy of the Tagal race, which is the only one in favor of the insurrection, and the subversion of all others, and he is fighting for a crown." And yet what a hypocritical howl goes up from the anti about the criminal sacrifice of life!

Ease of the Ministry.

Aprons of local changes in the ministry which are frequently taking place, it may not be amiss to make a few commonplace observations. The minister, like the public school teacher, has, in the eyes of the community an easy position to fill. To be sure he must preach about two sermons a week, but that is in his line and comes to him quite as a matter of inspirational habit. The same is said of funeral services and such other light duties as may devolve upon him in the meantime. As for the rest he has only to visit his flock, attend the sick and the poor of the community, look after the business interests of his church, lead the deliberations of the missionary society, act as a sponsor for half a dozen more or less benevolent enterprises and attend numerous delightful social functions, planned for his special felicity. In the meantime some of his congregation may be a little disaffected toward him and seek, therefore, to institute oyster proceedings against him in the mind of the community. Still he can easily wrestle with the adverse conditions by smiling sweetly on his enemies and preaching into their unwilling ears the beautiful doctrine of love. Now if his other duties are a little perplexing he has recourse to the consolation of his religion, and there is his wife to comfort and help him. By the way, he must have a wife. Whereas formerly the clergy was a celibate body and sworn to poverty, the modern unmarried preacher is persona non grata to the church. It is feared, as has happened on occasion, he will cut undisciplined capers and soil the ministerial cloth, so he must throw himself devotedly upon the matrimonial market early in the game, invite the first feminine opportunity in sight to share the uncertainties of his very problematic future—in short, become a benedict or burst, or become a benedict and burst to be more accurate. But in addition to all these troubles the preacher must preach. It has been said that there are ministers who have something to say and those that have to say something. The latter class is the only one extant under the present condition of public demand. The present day preacher must preach on all occasions. He must compose two sermons a week with funeral sermons and innumerable difficult "talks" thrown in. His compositions must always present the same theme with enthusiasm and freshness. At this rate he must write six or eight classic volumes per year! Enough to make the shades of Scott and Dumas groan. And yet he has an easy time of it and is rather inclined to be lazy. So says the community. But just let the community try a week, fall down over its job, incur the displeasure of its congregation and try to continue preaching the doctrine of love to unfriendly ears and it will very likely conclude that the minister's path is not all roses and that whereas he often preaches them the doctrine of love and gentleness for harmony's sake he would be justified in going at them with fire, hammer and tongs for the benefit of their liberality

and hypocrisy. The average preacher like the average man, is fallible because he is human, but he should not be denied the credit to which his talents entitle him, even if he can not compass absolute divinity.—Newcastle (Ind.) Courier.

AN ELOQUENT COUNCIL SESSION.

The Pastors of the city churches appear before the city fathers in behalf of the enforcement of the Sunday closing law.

It has been evident to all for some time that some of the city ordinances have been, if at all, very carelessly enforced. The blame cannot be placed upon the council any more than upon the citizens, but the fact has remained just the same. Among these ordinances, the Sunday closing law is prominent. Several business establishments have been keeping open which have no right to by the Sunday ordinance. A report got out the other day that the council was contemplating repealing said ordinance, and the pastors learning of it, attended the regular session Monday evening to enter a protest. When invited by Mayor Hadley to state their case, Rev. Barr of the Friends church as president of the ministerial association, spoke first. He referred to the fact that a motion had been made and seconded in a previous council meeting to repeal the Sunday closing law, and continued with a strong protest against any such action. He spoke of bicycle shops, photo galleries and places of congregation for gambling, which had no legal right for being well open as they were. Violation is no argument for repeal and he advised rigid enforcement in behalf of the Christian people of the town.

Rev. Day said they were not there to ask for radical measures, but that men should be repressed who do business for gain on Sunday. Their influence on the young is pernicious. He said it was childish to speak of repealing laws because they were not enforced. Why not repeal all law?

Rev. Snyder said it was unfair that a business man should be a slave to a community by keeping open seven days of the week. If one man does business on Sunday others who respect the law are placed at a disadvantage. He knew of several Christian families who intended locating here, who will not come if our moral ordinances are not to be enforced. Rev. Hall of the same church, also referred to the fact that he had recommended Newberg to Eastern friends as a law abiding place and wanted to be upheld in his recommendation.

Rev. Launer stated that before he came here he had always heard of Newberg as a strictly moral place. She has a good reputation now and the pastors tender their support in keeping it good. All the speakers were given a very attentive and respectful hearing by the councilmen present. Mr. Parker stated that there was no intention of repealing the ordinance and others intimated that as they were assured of the support of the people, they favored rigid enforcement. An interesting general discussion took place in regard to existing conditions in town, and some rather sensational facts were disclosed. One councilman testified to having seen on last Sunday a clerk take some men into a certain store "not far from the council chambers" and that all came out wiping their mouths suspiciously. This was not nearly as surprising however as some other facts divulged.

Before adjourning, the councilmen present, Parker, Hodson, Heater and Cooper, voted unanimously for the rigid enforcement of the Sunday ordinance. This will close all places of business but the livery stable, meat shops and drug stores. And in regard to the latter, it was suggested that a provision be made that drug stores be allowed to dispense nothing but medicines. We believe the people will stand by the council on the stand they have taken.
