In the lexicon of the Newberg Development Company—there is no such word as fail. Make up your mind as to that fact right now.

A strong, experienced man in congress, whose ability is recognized by his illustrious colleagues, is an honor to our state. You are voting for just such a man when you cast a vote for Congressman Thos. H. Tongue.

Absolutely, the mostest man we have heard of up to date is the fellow who sits around and growls at the prospect of the best sugar factory because it will make taxes higher. We pin our hope to the belief that there are few like unto him.

Last year in Utah, the farmers raised four thousand, three hundred acres of sugar beets. This year they are arranging to grow eight thousand acres—practically double the amount. Does this favor very strongly of dissatisfaction among the farmers?

Farmers who say they want the sugar factory to come but who are unwilling to subscribe any acreage themselves are standing in their own light. It is going to take a united effort to secure the required amount and none can afford to turn the cold shoulder to the solicitors.

A vote for the return of Hon. Clarence Butt to the legislature is a vote for a man in every way worthy of the support of the people. He is honest and conscientious and having had the experience of one term in the house he is well qualified to represent Yamhill county in next winter's session.

The fiercely fought contests which took place in the state republican conventions of Indiana and Illinois for the gubernatorial nomination is pretty good evidence that those states are not considered very "doubtful"—except by the democrats when making up their cheerful forecasts.

And now they have a "Bryan" ticket in Oregon. What next! When will democrats come to their senses and demand the old and tried name of democracy to fly at the mast head? Just as long as they prostitute the sin of office getting as being paramount to party policy, so long will they be defeated. Watch the vote in Oregon.—Centralia (Wash.) News, democratic.

The fusion politicians in this county, it seems, have decided upon a "still hunt." Cooper's "Campaign" sheet at the county seat has suspended publication, presumably because no one was willing to put up for a forlorn hope. Probably it has already been discovered that political fusion doesn't fuse, any longer than the solder is hot, and it hasn't been very warm any of the time between the two principal parties to the attempted union.—Sheridan Sun.

The Oregonian very weakly tries to explain the favorable committee reports made on bills introduced by Senator McBride with the remark that "The Senate takes a kindly and helpful interest in the re-election of its members." This is entirely on the same basis that after McKinley's election, charges were made that Hanna opened up the factories to give an appearance of prosperity. The big daily allows its feverish ambition to defeat Oregon's senior Senator to over leap itself.

The fusionists or "Bryans" fully realize that they have a hard proposition before them in this county, and are up to anything to gain a place or two among the county offices. Therefore it pays

the republicans to beware of the smooth politician who says there is no politics in the election of county officials. Beware of the man who buttonholes you for a "trade." The republican ticket is clean and strong and there is no reason why every man on it cannot be elected if the republicans will stand unflinchingly by their colors.

Has any one ever seen a word of sympathy in a republican paper for the struggling Boers in South Africa, in their efforts to retain their liberty. This is significant, and shows where the tendency of the party is.—Albany Democrat.

The republicans have a decidedly enviable record on the subject of human slavery in our own country, and they have no intention of annulling it by countenancing any other people which is still practicing the barbarous and heathenish custom of bartering in human lives. If this "tendency is significant" make the most of it.

The testimony received from LaGrande in reference to the success which the farmers have experienced there in the raising of sugar beets, should have great weight with the farmers of Yamhill county who are contemplating engaging in the great coming agricultural industry. The LaGrande farmers have succeeded in spite of very adverse conditions, and a close reading of the personal letters published in last week's issue will show that we have much greater opportunities than they, and may reasonably hope for even greater success. In the first place, the country surrounding LaGrande is owned in large tracts, and contracts were made for acreage in proportion. It was thus difficult to give proper cultivation to the crop. On the other hand in this vicinity, which is divided up into small tracts, greater care could be taken of the beets with a result of doubling the crop. It is the same old issue of extensive versus intensive farming which is bound to result in favor of the latter. Again, some of the LaGrande growers are business men, who hire all their work done, and even have no supervision of the work. If they can make money on that basis, what can the experienced farmers of this section do, with personal oversight, and with little need of hired help? There is no reason why our farmers should not take hold of this matter with a vim and determination which will make them the most prosperous agriculturists in the state.

We are not very radical on the "cow" question, to be voted on at the coming election, but believe voters should give this, as well as some of the more sharply defined political issues, careful attention. The issue is practically between the bicyclists and the people who do not own private pasture for stock. As the Graphic both rides a bicycle and keeps a cow, it should be credited with speaking on the question entirely without prejudice. It is true the cows appreciate the advantage of the bicycle paths for locomotion purposes, and will continue to do so as long as allowed to run at large. But the question is, is this inconvenience to bicyclists serious enough to justify forcing many poor people to part with faithful old Fide, the family cow, which furnishes a good share of the living. For this is just what such action would amount to, with very many families right here in Newberg. We do not believe the justification is sufficient. It is claimed that it is an injustice for farmers to be compelled to keep up such good fences. This will scarcely hold water however, as a farmer has to have a good fence to keep his own stock in as well as others out. And in favor of the cow we will say that she does good service in keeping our highways looking as clean as they do. For instance in some Eastern states where the cow curfew law is in effect, we have seen the road ways grow up in weeds, and grasses, and the fences falling away and neglected, giving the farms and country in general a very dilapidated appearance. Taken altogether, we think the old cow has some pretty good argument on her side, for consideration of the voters.

As a rule, the Graphic is not much given to pronouncing individual eulogies on its candidates for office, believing that the fact that they have been honored with a place on the republican ticket is sufficient recommendation as to their integrity and ability. Circumstances alter cases however, and we believe that the candidacy of our fellow citizen J. L. Hoskins for the office of county recorder, calls for a few special words. We call especial attention to his defense by the Sheridan Sun, reproduced in this issue. It speaks some well known facts of Yamhill's political history, in a straight-from-the-shoulder manner which will prove embarrassing to Mr. Hoskins' opponents, for the very reason that they recognize their truth. In short Mr. Hoskins was the victim of treachery and vilification which stand out as a blot against Yamhill's fair name. "Politics is politics" certainly enough, but there should be honor even there. And when a party starts out to defeat a man by the circulation of patently and ridiculously false "campaign" stories, it is likely to find a hidden but effective boomerang. As indicated by the Sun, such methods have already been put in use, but we believe the voters of Yamhill cannot be fooled a second time. For his staunch integrity, notable ability and loyal and self-sacrificing support of the best interests of the county, there is not a man more honored and better thought of in this whole section than plain, unassuming and sociable Lew Hoskins. His standing at home should speak volumes in his behalf, and we confidently predict that he will receive in this end of the county a decidedly larger majority than has ever been given to any candidate for any office on any ticket.

It has been suggested that if the democratic party could secure a new platform, new managers and a new candidate as easily as they secure a new convention hall, the republicans might not feel so confident of the result of the coming election.

WORTHILY CHAMPIONED.

The Sheridan Sun Aably Defends the Candidacy of J. L. Hoskins for Recorder.

The fusion political schemers are deceiving themselves with a false hope of defeating J. L. Hoskins, the republican nominee for recorder. They base their hopes solely on the fact that in 1892 Mr. Hoskins was defeated for county clerk by a plurality of 54 votes. If the same methods were put in practice again and could be depended on to work equally well, perhaps it might succeed, but some of the essential elements are lacking and the voters have their eyes open to the disgraceful impositions perpetrated at that time. It is a well known fact that the defeat of Mr. Hoskins was accomplished at a cost approximating the value of a good sized farm, in a campaign in which all the corrupting and demoralizing influences known to bad politics were arrayed. The annals of Yamhill politics furnish not another such disgraceful spectacle. Money, whiskey, Indian votes and falsehood were the elements that weighted the balances against him, and it became so notorious that many of the most respectable voters in the opposition party have ever since felt the reparation of a gross wrong was due Mr. Hoskins. It is safe to say that no republican will again be deceived by the repetition of the old falsehoods, or any new ones that the opposition may invent, and no one, if so disposed and possessed of the "wherewithal," would have the hardihood to risk another "barrel" in compassing his defeat. The pay of the recorder's office would not justify it; neither would that of the clerk's office since the abolition of the fee system. We refer to this matter reluctantly and only because an attempt is being made by some of the opposition to revive the old falsehoods that did service in the former campaign. It is the highest possible endorsement of Mr. Hoskins, and ample denial of anything that may be said to his disparagement, that the republicans of Newberg have again placed the seal of approval upon him and put him forth as a candidate. He belongs to the solid Quaker fraternity that has made the name of Newberg the synonym of progress and good citizenship; he is not a "crank" at all, is neither a Jew nor a Catholic, as they claim, but a kind, genial and affable gentleman in plain dress, an old soldier, and in every sense an honorable citizen of Yamhill county.
